# BY-LAW

## BY-LAW NUMBER 033-2024

**A By-law to amend the Fees and Charges By-law 224-2023 to adjust the Development Engineering fees.**

**WHEREAS** sections 8, 9 and 11 of the Municipal Act, 2001, S.O. 2001, c.25 (“Municipal Act, 2001”), authorize a municipality to pass By-laws necessary or desirable for municipal purposes, and in particular paragraph 3 of subsection 11(2) authorizes by-laws respecting the financial management of the municipality;

**AND WHEREAS** Section 142 of the Municipal Act, 2001 authorizes local municipalities to require that a Permit be obtained for the Placement of fill, the Removal of Topsoil, or the alteration of the Grade of land, and to impose conditions to such Permits; and,

**AND WHEREAS** section 391 of the Municipal Act, 2001 similarly permits a municipality to pass By-laws imposing fees and charges on persons for services or activities provided or done by or on behalf of it;

**AND WHEREAS** By-law 224-2023 to provide for Fees & Charges for the calendar years 2024 and 2025 was adopted by Council on December 12, 2023;

**AND WHEREAS** it is deemed necessary to amend Schedule “K” Development Engineering to reflect new permit and administrative fees as approved by Council on February 21, 2024;

**NOW THEREFORE** the Council of The Corporation of the City of Vaughan ENACTS AS FOLLOWS:

1. That the Site Alteration Section under Schedule “K” Development Engineering be deleted and replaced with the following:
