



## Road, Watermain & Sewer Improvements within the Old Maple Area

### PROJECT UPDATE

The City of Vaughan is planning road, sewer and watermain improvements in your area to replace aging infrastructure, as part of the 2021 Capital Program.

### PLANNED PROJECT WORK

Proposed work details at the various locations, as indicated on the above map include:

- Road rehabilitation
- Watermain replacement including water service connections to the property line
- Stormwater rehabilitation

### PRE-CONSTRUCTION FIELD WORK

Over the next few weeks, engineering consultants will be on your street collecting field data and conducting investigation activities for the project which may include topographic and/or legal surveys, geotechnical boreholes and other field investigation works.

### TRAFFIC IMPACT

All roads listed will remain open to traffic while the field investigation work is being carried out by the City-approved consultant, under the direction of the Infrastructure Delivery department.

### MORE DETAILS TO FOLLOW

Newsletter No. 2 will be issued prior to construction, which will provide further details and an approximate start and end date for construction. The road and water rehabilitation work is tentatively scheduled for 2021.
