On Wednesday October 30, 2019, the City of Vaughan and the City's lead consultant, Macaulay Shiomi Howson Ltd., will host the first in a series of Public Open House meetings in preparation of the Promenade Centre Secondary Plan (Promenade Centre) and Comprehensive Transportation Study. The Promenade Centre Study Area is generally bounded by Centre Street, Bathurst Street, Clark Avenue West and New Westminster Drive; which includes the Promenade Mall and surrounding area (see map on reverse).

PURPOSE OF THE STUDY:

The City of Vaughan is undertaking a Secondary Plan for the Promenade Centre as required by the Vaughan Official Plan 2010 (VOP 2010). The Secondary Plan will provide the policy framework and resulting land use plan to guide the future development of Promenade Centre. The Plan will assist in refining the role of the Promenade Centre to implement the policies of VOP 2010 and provide opportunities for redeveloping the Study Area as a complete, mixed-use community that is transit-supportive.

PURPOSE OF THE MEETING:

The Visioning Summit and Workshop will provide those in attendance with information regarding the study process for the Promenade Centre and accompanying Comprehensive Transportation Study. The summit and workshop will provide an opportunity to:

- discuss the existing conditions and characteristics of the Study Area and surrounding neighbourhoods
- opportunity to review background information regarding the study
- consider the issues and opportunities respecting future development of the Study Area
- share your views for a vision and related principles to guide future development of Promenade Centre and a secondary plan for the area

The workshop component of the evening will include round table discussions and activities to obtain public input on the future of Promenade Centre to inform the preparation of the Secondary Plan.
