There are three types of lobbyists:

- You are a consultant lobbyist if you lobby for payment on behalf of a client (another individual, company, partnership or organization).
- You are an in-house lobbyist if you are an employee, partner, or sole proprietor, or a member of a board of directors and who lobbies on behalf of their own employer, business or organization.
- You are a voluntary unpaid lobbyist if you lobby without payment on behalf of an individual, business, or other organization for the benefit of the interests of the individual, business or other organization.
