

SPECIAL EVENT INVITATION FOR REFRESHMENT VEHICLES LICENSED OUTSIDE OF VAUGHAN

THE APPLICATION PROCESS

This document is intended for City of Vaughan (City) Special Event organizers to **invite Refreshment Vehicle Owners who are <u>not</u> licensed in Vaughan, to operate at their event**. (Note that Refreshment Vehicle Owners who have a City licence <u>do not</u> require an Event licence or need to use this document.) This permit is intended for refreshment vehicles licensed in other municipality with similar licensing requirements to Vaughan; if staff believe the licensing requirements are different, you may be asked for additional information.

How to apply

- 1. If a Vaughan Special Event permit holder would like to invite a refreshment vehicle that is not licensed in the City of Vaughan, to operate at a special event, the permit holder should complete this form and give it to the vehicle owner, advising them to apply for a <u>Refreshment Vehicle Event</u> permit using the information on this invitation.
- 2. The City Special Event permit holder should also submit to the City a list of Refreshment Vehicles that will be operating at their event.
- 3. Refreshment Vehicle Owners should submit this document as part of their <u>Refreshment Vehicle Event</u> permit application to the City, along with applicable fees as listed at <u>vaughan.ca/BusinessLicensing</u>.

How to apply

You can complete the Refreshment Vehicle Event I application (with this document) in four different ways:

- 1. Licensing Portal where you can apply online, posted at vaughan.ca/BusinessLicensing.
- 2. Mail to the By-law and Compliance, Licensing and Permit Services Department.
- **3. Drop off** to drop-boxes located at the entrances of Vaughan City Hall, with the enveloped marked, "Attn: By-law and Compliance, Licensing and Permit Services".
- **4.** By e-mail to bylaw.licensing@vaughan.ca, along with scanned copies of required documentation, and an e-mail indicating a contact phone number for staff to collect payment.

SPECIAL EVENT INFORMATION FOR REFRESHMENT VEHICLES THAT ARE <u>NOT</u> LICENSIED IN THE CITY OF VAUGHAN

- Refreshment Vehicle Owners who are not licensed with the City of Vaughan, must submit this document along with their <u>Refreshment Vehicle Event</u> permit application.
- Note that Refreshment Vehicles with Event licences may only operate during the authorized event.
