PROPOSAL

By-law 1-88 zones this parcel Old Village Residential Zone "R1V". The applicant is requesting  
a variance to permit the continued construction of a two-storey single family detached dwelling  
with an attached garage and the construction of a proposed dome skylight in the centre of the  
roof, notwithstanding, the maximum building height is 10.75m and will be 11.67m with the  
skylight rather than the required 9.5m.
