**Purpose:**

Relief from the by-law is being requested to permit a secondary suite within the existing dwelling, an expansion to the existing driveway and the existing shed located in the rear yard.

The following variances are being requested from By-Law 1-88, as amended, to accommodate the above proposal:

By-law Requirement	Proposal
1. A minimum interior side yard setback of 1.5 meters is required to a deck and stairs.	1. To permit a minimum interior side yard setback of 0.83 metres to a deck and stairs.
2. A Secondary Suite shall not exceed 45% of the total gross floor area of the Semi-Detached Dwelling.	2. To permit a total gross floor area of 59.93% of the Semi-Detached Dwelling to be a Secondary Suite.
3. A maximum driveway width of 3.75 metres is permitted.	3. To permit a maximum driveway width of 5.4 metres.
4. A minimum rear yard setback of 7.5 metres is required to an accessory structure (shed).	4. To permit a minimum rear yard setback of 1.25 metre to an accessory structure (Shed).
5. A minimum interior side yard setback of 1.5 metres is required to an accessory structure (shed).	5. To permit a minimum interior side yard setback of 0.66 metres to an accessory structure (Shed).

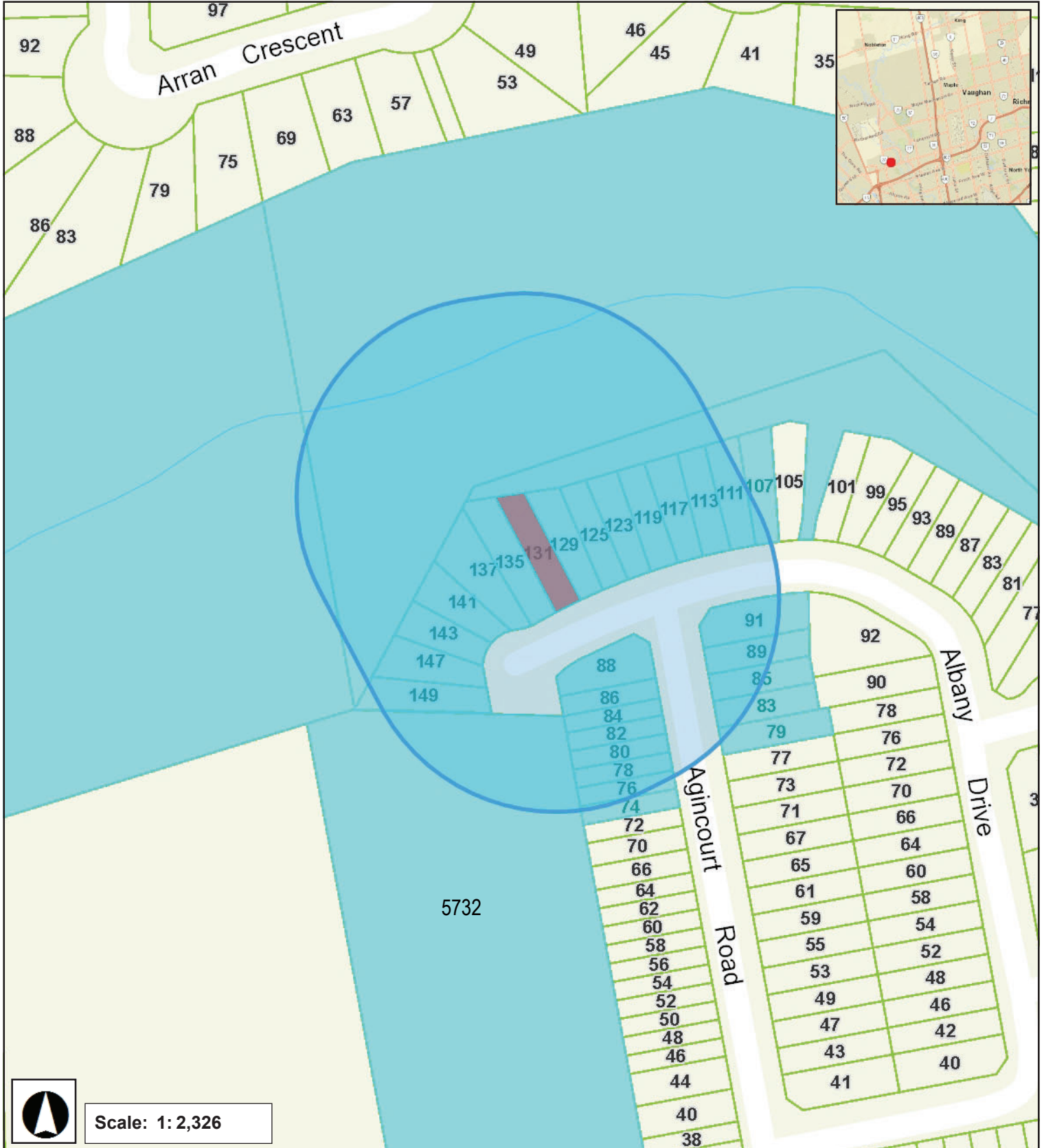
