1. A minimum rear yard setback of 1.5 metres is required to the inground swimming pool.	1. To permit a minimum rear yard setback of 1.22 metres to the inground swimming pool.
2. A minimum interior side yard setback of 1.5 metres is required to the inground swimming pool.	2. To permit a minimum easterly interior side yard setback of 1.1 metres to the inground swimming pool.

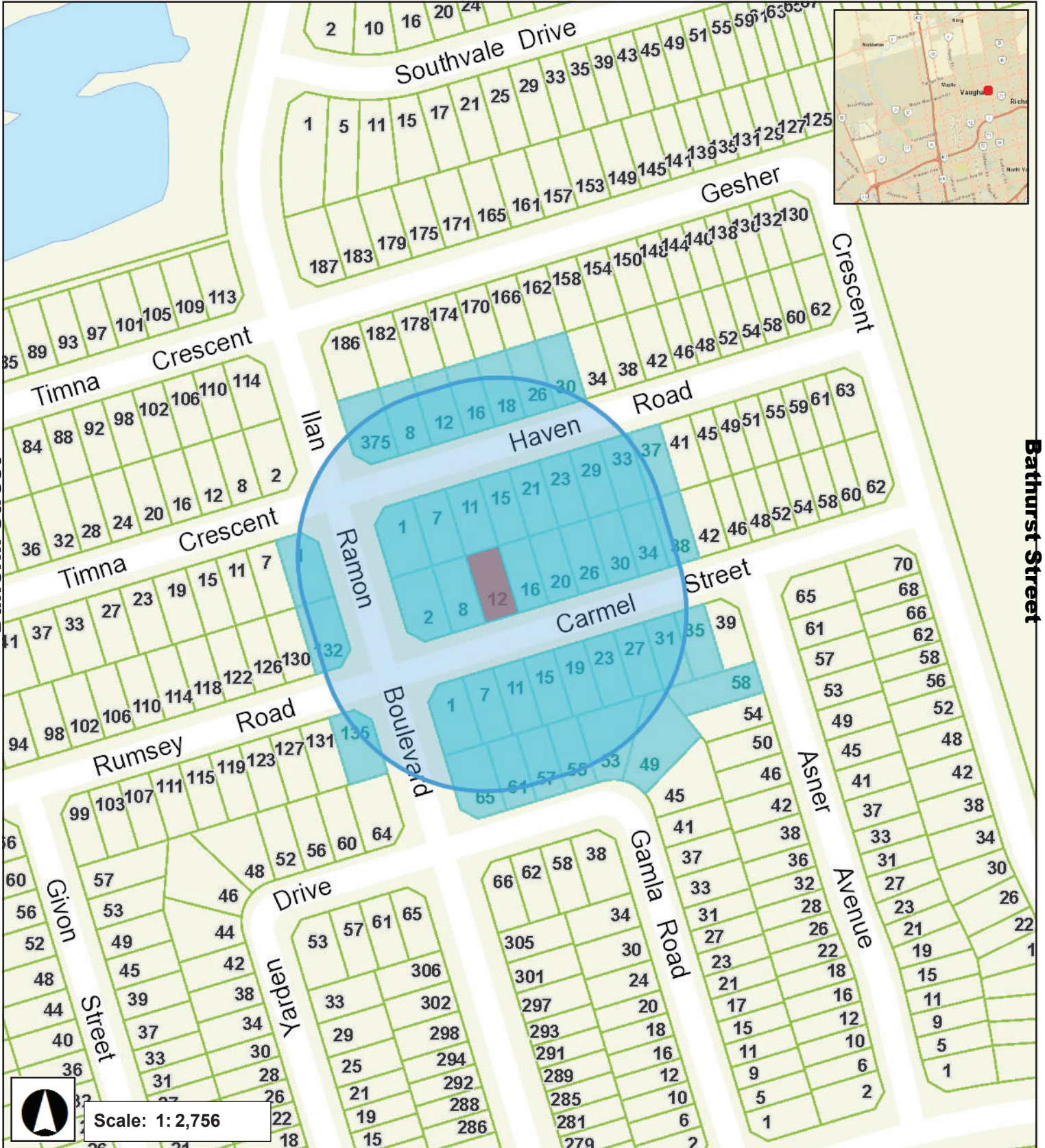
