BY-LAW

BY-LAW NUMBER 020-2018

A By-law to amend By-law 370-2004, as amended, being a By-law to provide for the issuing, revoking, and/or suspending of permits and for regulating and inspecting special events within the City of Vaughan.

WHEREAS section 11. (2) 5. of the *Municipal Act, 2001*, S.O. 2001, c. 25, as amended (the "*Municipal Act, 2001*"), provides that a municipality may pass By-laws respecting the economic, social and environmental well-being of the municipality;

AND WHEREAS section 11. (2) 6. of the *Municipal Act, 2001* provides that a municipality may pass By-laws respecting the health, safety and well-being of persons;

AND WHEREAS the Council of The Corporation of the City of Vaughan has enacted By-law 370-2004, as amended, to provide for the issuing, revoking, and/or suspending of permits and for regulating and inspecting special events within the City of Vaughan;

AND WHEREAS the Council of The Corporation of the City of Vaughan has determined that it is desirable to make amendments to the Special Events By-law 370-2004, as amended;

NOW THEREFORE, the Council for The Corporation of the City of Vaughan ENACTS AS FOLLOWS: s

1. Adding the following paragraph to Section 3.0 PROVISIONS:

 “(7) If a fee for a particular year is not prescribed in Schedule “A”, and a budget has not been passed by January 1st in a given year, the Treasurer is authorized to apply a 3 per cent increase to the fee applied in the previous year to account for economic adjustment.”
2. By-law number 370-2004 is hereby amended by deleting “Schedule A” and substituting Schedule ‘A’, attached hereto.
3. This By-law shall come into force and effect on January 30, 2018.
