 - Secondly: Part of Lot 6, Concession 9, designated as Parts 3 and 5 on Plan 65R-34407, which is registered in the Land Registry Office for the Land Titles Division of York Region (No. 65);

be and they are hereby dedicated as part of public highway known as "Runway Road".

3 THAT the lands which are situate in the City of Vaughan, in the Regional Municipality of York, being

- Firstly: Part of Lot 6, Concession 9, designated as Parts 22 and 25 on Plan 65R-34359, which is registered in the Land Registry Office for the Land Titles Division of York Region (No. 65).
- Secondly: Part of Lot 6, Concession 9, designated as Parts 4, 12 and 18 on Plan 65R-34327, which is registered in the Land Registry Office for the Land Titles Division of York Region (No. 65);
- Thirdly: Part of Block 31, Plan 65M-3992, designated as Part 5, on Plan 65R-34327 which is registered in the Land Registry Office for the Land Titles Division of York Region (No. 65);

be and they are hereby dedicated as part of public highway known as "Motion Court".

4. THAT the lands which are situate in the City of Vaughan, in the Regional Municipality of York, being Part of Lot 6, Concession 9 and 10, designated as Parts 2, 6, 11 and 12 on Plan 65R-34407, which is registered in the Land Registry Office for the Land Titles Division of York Region (No. 65).

be and they are hereby dedicated as part of the public highway known as "Huntington Road".
