SCHEDULE "A" TO BY-LAW NUMBER

METERED ACCOUNTS

A. Water - Consumption Rate

\$1.4780 per cubic meter based on water consumption effective with water meters read starting on April 1, 2015.

B. Minimum Invoice Charge Per Month

\$9.00 per Month

UNMETERED ACCOUNTS

Rate Per Month - \$17.30

This rate shall be charged for each unit on the premises and a "unit" shall be a room or rooms or part of a building that is separately assessed on the assessment roll or capable of being assessed.

SERVICE CHARGES

A. Turn Off

- During Working Hours
(Monday to Friday from 8:00 a.m. to 3:30p.m.) \$46.00
- Other than Working Hours
(Including Weekends and Holidays) \$110.00

B. Turn On

- During Working Hours
(Monday to Friday from 8:00 a.m. to 3:30p.m.) \$46.00
- Other than Working Hours
(Including Weekends and Holidays) \$110.00

C. Turn On/Off

- Minimum Charge for Service Call \$46.00

(application for meters and temporary water fees)**

\$ at cost (varies with number of meters to be installed, size of meters, administration costs and contract installation costs)

Hydrant meter relocation will be subject to 15% Administration Fee of the Deposit. G.	Drinking Water Permit Fee	\$1,200 per application
H.	Sprinkler Connection	Site specific as quoted
I.	Water Connection	Site specific as quoted
J.	Water Disconnection	Site specific as quoted
K.	Temporary Building Water	Residential (per dwelling): \$ 20.00 per unit Commercial / Industrial / High Density Residential: (Total Gross Floor Area) \$ 2.00 per 1,000 sq. ft. / \$ 2.15 per 100 m ² (minimum \$20.00)
L.	Dewatering Study Areas	\$ 100.00 within 0.5 kms \$ 250.00 within 1.0 kms. (clerical activity to determine servicing for City water at properties within a prescribed area)
M.	Hydrant Flow Testing	\$ 104.00 per test (minimum two hours) \$ 52.00 for each additional hour
N.	Plumbing Not Ready	\$ 30.00 for each missed/cancelled meter Installation appointment
O.	Bacteria Testing – New Mains	\$ 85.00 each test point (applied after 2 tests – one or both unsuccessful at same location).
P.	Replacement of Lost Water Card	\$ 25.00 each
Q.	A charge of \$15.00 plus bank charges and applicable taxes shall be applied for each cheque returned by a bank or other financial institution.	
R.	General Administration Fee where applicable	15%
S.	Overdue accounts are subject to a late payment charge of 1.5% per month (compounded to 19.56% annually).
