# ***BY-LAW***

## **BY-LAW NUMBER 063-2014**

### **A By-law to dedicate certain lands as part of the public highway.**

The Council of The Corporation of the City of Vaughan ENACTS AS FOLLOWS:

1. THAT the lands which are situate in the City of Vaughan, in the Regional Municipality of York, being Part of Lots 16 and 17, Concession 2, being:

Firstly: Parts 4, 9 and 16 on Plan 65R-28971, registered in the Land Registry Office for the Land Titles Division of York Region (No. 65); and

Secondly: Parts 7 and 9, on Plan 65R-28968 registered in the Land Registry Office for the Land Titles Division of York Region (No. 65);

be and they are hereby dedicated as part of public highway known as "Valley Vista Drive".

2. THAT the lands which are situate in the City of Vaughan, in the Regional Municipality of York, being:

Firstly: Part of Lot 16, Concession 2, designated as Parts 6 and 8 on Plan 65R-28982, which is registered in the Land Registry Office for the Land Titles Division of York Region (No. 65);

Secondly: Part of Lot 17, Concession 2, designated as Parts 7, 8, 9, 11, 25 and 26 on Plan 65R-28995, which is registered in the Land Registry Office for the Land Titles Division of York Region (No. 65);

Thirdly: Part of Lot 16, Concession 2, designated as Parts 22 and 23, on Plan 65R-28995, which is registered in the Land Registry Office for the Land Titles Division of York Region (No. 65);

Fourthly: Part of Lot 16 and 17, Concession 2, designated as Part 66, on Plan 65R-28995, which is registered in the Land Registry Office for the Land Titles Division of York Region (No. 65); and

Fifthly: Part of Lot 19, Concession 2, designated as Part 22, on Plan 65R-28968, which is registered in the Land Registry Office for the Land Titles Division of York Region (No. 65).

be and they are hereby dedicated as part of public highway known as "Ilan Ramon Boulevard".

3. THAT the lands which are situate in the City of Vaughan, in the Regional Municipality of York, being:

Firstly: Part of Lot 17, Concession 2, designated as Parts 13, 15 and 29 on Plan 65R-28995, which is registered in the Land Registry Office for the Land Titles Division of York Region (No. 65);

Secondly: Part of Lot 16 and 17, Concession 2, designated as Parts 27 and 31, on Plan 65R-28995, which is registered in the Land Registry Office for the Land Titles Division of York Region (No. 65); and

Thirdly: Part of Lot 16, Concession 2, designated as Parts 32, 45, 46, 47, 68, 70, 86 and 88, on Plan 65R-28995, which is registered in the Land Registry Office for the Land Titles Division of York Region (No. 65).

be and they are hereby dedicated as part of public highway known as "Marc Santi Boulevard".

4. THAT the lands which are situate in the City of Vaughan, in the Regional Municipality of York, being:

Firstly: Part of Lot 17, Concession 2, designated as Parts 1 and 54, on Plan 65R-28995, which is registered in the Land Registry Office for the Land Titles Division of York Region (No. 65);

Secondly: Part of Lots 16 and 17, Concession 2, designated as Parts 3 and 52, on Plan 65R-28995, which is registered in the Land Registry Office for the Land Titles Division of York Region (No. 65);

Thirdly: Part of Lot 16, Concession 2, designated as Parts 33, 34, 35, 40, 41, 74, 76, 80 and 82 on Plan 65R-28995, which is registered in the Land Registry Office for the Land Titles Division of York Region (No. 65); and

Fourthly: Part of Lot 16, Concession 2, designated as Part 33 on Plan 65R-28975, which is registered in the Land Registry Office for the Land Titles Division of York Region (No. 65).

be and they are hereby dedicated as part of public highway known as "Thomas Cook Avenue".

5. THAT the lands which are situate in the City of Vaughan, in the Regional Municipality of York, being Block 62 on Plan 65M-3999, registered in the Land Registry Office for the Land Titles Division of York Region (No. 65);

be and they are hereby dedicated as part of public highway known as "Heritage Estates Road".

6. THAT the lands which are situate in the City of Vaughan, in the Regional Municipality of York, being Blocks 30 and 31 on Plan 65M-3918, registered in the Land Registry Office for the Land Titles Division of York Region (No. 65);

be and they are hereby dedicated as part of public highway known as "George Kirby Street".

7. THAT the lands which are situate in the City of Vaughan, in the Regional Municipality of York, being Blocks 37 and 39 on Plan 65M-3918, registered in the Land Registry Office for the Land Titles Division of York Region (No. 65);

be and they are hereby dedicated as part of public highway known as "Littleriver Court".

8. THAT the lands which are situate in the City of Vaughan, in the Regional Municipality of York, being Block 127 on Plan 65M-3917, registered in the Land Registry Office for the Land Titles Division of York Region (No. 65);

be and they are hereby dedicated as part of public highway known as "Cooks Mill Crescent".

9. THAT the lands which are situate in the City of Vaughan, in the Regional Municipality of York, being Block 226 on Plan 65M-3985, registered in the Land Registry Office for the Land Titles Division of York Region (No. 65);

be and they are hereby dedicated as part of public highway known as "Mill River Drive".
