# ***BY-LAW***

## **BY-LAW NUMBER 075-2014**

**A By-law to amend City of Vaughan By-law 1-88.**

**WHEREAS** the matters herein set out are in conformity with the Official Plan of the Vaughan Planning Area, which is approved and in force at this time;

**AND WHEREAS** there has been no amendment to the Vaughan Official Plan adopted by Council but not approved at this time, with which the matters herein set out are not in conformity;

**NOW THEREFORE** the Council of the Corporation of the City of Vaughan **ENACTS AS FOLLOWS:**

1. That City of Vaughan By-law Number 1-88, as amended, be and it is hereby further amended by:
  - a) Deleting the words “and Part 2” in Exception 9(194) and in Exception 9(194), clause a) vii).
  - b) Deleting the text in Exception 9(194), clause c) and substituting therefor the word “Deleted”.
  - c) Deleting the text in Exception 9(194), sub-clause e) i) (4) and substituting therefor the word “Deleted”.
  - d) Deleting the text in Exception 9(194), sub-clause e) i) (5) and substituting therefor the word “Deleted”.
  - e) Deleting the text in Exception 9(194), sub-clause e) ii) (3) and substituting therefor the word “Deleted”.
  - f) Deleting the text in Exception 9(194), sub-clause e) ii) (4) and substituting therefor the word “Deleted”.
  - g) Deleting Schedule “E-200” and substituting therefor the Schedule “E-200” attached hereto as Schedule “1”.
  - h) Deleting Schedule “E-200a” and substituting therefor the Schedule “E-200a” attached hereto as Schedule “2”.
  - i) Deleting Schedule “E-200b” and substituting therefor the Schedule “E-200b” attached hereto as Schedule “3”.
  - j) Deleting Schedule “E-200d” and substituting therefor the Schedule “E-200d” attached hereto as Schedule “4”.
  - k) Deleting Schedules “E-200h”, “E-200i”, “E-200j”, “E-200l”, “E-200m” in their entirety from By-law 1-88.
  - l) Deleting Key Maps 5D and 5E and substituting therefor the Key Maps 5D and 5E attached hereto as Schedules “5” and “6”.

2. This By-law comes into effect on the day that By-law 075-2014 amending By-law 1-88, as amended, comes into effect for the lands shown on Schedule "7".
3. Schedules 1, 2, 3, 4, 5, 6 and 7 shall be and hereby form part of this By-law.

### **SUMMARY TO BY-LAW 075-2014**

The lands subject to this By-law are located on the north side of Major Mackenzie Drive, and the west side of Jane Street through to Highway No. 400; in Part of Lots 20 and 21, Concession 5, City of Vaughan, Ward 1.

The purpose of this by-law is to delete all reference to the subject lands described above, including text and schedules in Exception Paragraph 9(194).
