The road name changes were advertised for two consecutive weeks on the City Page of the City's website. The name change will not affect any homeowners as there are currently no area residents residing on this street. Emergency services have been notified of the proposed name change.

Purpose

To enact a by-law to change the name of Street "KK" from Chesley Crescent to Card Lumber Crescent, and Streets "QQ" and "RR" from Agar Street East and Agar Street West to East's Corners Boulevard.

Background - Analysis and Options

At its meeting of June 25, 2013, Council directed staff to commence procedures as required by the Municipal Act to advertise and schedule a Public Hearing to change the name of Street "KK" from Chesley Crescent to Card Lumber Crescent, and Streets "QQ" and "RR" from Agar Street East and Agar Street West to East's Corners Boulevard.

The notice (Attachment 1) was advertised on the City Page of the City's Website on August 29th and September 5th, 2013. The appropriate agencies have been notified of the proposed changes. No objections have been received.

Relationship to Vaughan Vision 2020/Strategic Plan

This report is consistent with the strategic goals as set forth in Vaughan Vision 2020/Strategic Plan, particularly "Manage Growth and Economic Well-Being".

Regional Implications

The Regional Municipality of York has no objection to the proposed street name changes.
