Economic Impact

The City's share of these property tax adjustments is approximately \$75,674. A provision for tax adjustments has been budgeted. There is a budget pressure but the office of the Chief Financial Officer is able to manage it from within.

Communications Plan

As required by the Act, notification of this meeting has been sent to all applicants and persons in respect of whom the applications were made, at least 14 days prior to the meeting. Notices of Decisions will be issued to all applicants detailing the total amount of the adjustment and the right of the applicant to appeal the decision to the Assessment Review Board.

Purpose

To obtain Council's approval for the increase or cancellation of property taxes as permitted under Section 354, 357 and 358 of the *Municipal Act, 2001.*

Background - Analysis and Options

The City prepares these types of reports two times a year. The prior report was prepared for Council on March 21, 2017. There were Twenty-eight applications on that report and the total cancellation, reduction or refund of taxes amounted to \$255,522. The City portion was \$50,423 or approx. 20%.

For the current report, Sixty-four (64) applications have been prepared for Council's consideration for the cancellation, reduction or refund of taxes for the current and prior tax years, under sections 354, 357 and 358 of the *Municipal Act, 2001, as amended*. There are various reasons for tax adjustments such as property becoming exempt, roll numbers being cancelled by the Municipal Property Assessment Corporation (MPAC), buildings that have been demolished or razed by fire,

and properties that have been over assessed by a gross or manifest clerical error. These tax adjustments do not relate to collection issues.

The total cancellation, reduction or refund of taxes, as recommended is \$439,119. The City portion of this amount is approximately \$75,674, or approximately 17% broken down per year as follows:

2013 = \$1,622 / 2014 = \$9,181 / 2015 = \$8,379 / 2016 = \$21,164 / 2017 = \$35,327

The City's share of the total adjustments for the 2017 tax year is \$126,097 (\$50,423 + \$75,674).

Following the approval of these adjustments, the applicants will have the right to appeal the decision to the Assessment Review Board within 35 days.

Relationship to Term of Council Service Excellence Strategy Map (2014-2018)

The cancellation or increase of property taxes as permitted under Section 354, 357 and 358 of the *Municipal Act, 2001,* supports the strategic priorities established by the Service Excellence Strategy Map, in particular Consistent Service Delivery as well as to ensure "Financial Sustainability".

Regional Implications

The Region's share of these property tax adjustments is approximately \$129,730 or approx. 29%.

Conclusion

The Municipal Act will allow staff to proceed with the property tax adjustments as applicable. Council approval also gives the applicant the right to appeal the decision to the Assessment Review Board if so desired.

Background - Analysis and Options

Correspondence was received from the Executive Director of ACYR in the Office of the City Clerk.

The proclamation request meets the requirements of the City's Proclamation Policy, as follows:

"That upon request, the City of Vaughan issue Proclamations for events, campaigns or other similar matters:

(i) which are promoted by any organization that is a registered charity pursuant to Section 248 of the Income Tax Act".

World AIDS Day provides an opportunity for people worldwide to unite and show their support for people living with HIV/AIDS, to commemorate those who have passed away, and to eliminate the stigma and discrimination by raising awareness about HIV/AIDS. It is estimated that more than 30, 000 people in Ontario are living with HIV, with York Region being home to over 400 people living with and impacted by HIV. ACYR is the only local non-profit organization that provides life changing supports to people living with and affected by HIV/AIDS. Council has granted this request previously.

The Chief Corporate Initiatives and Intergovernmental Relations, in consultation with the Senior Manager of Economic Development and Culture Services and City Solicitor, recommends:

Contribution to Sustainability

Green Directions Vaughan embraces a sustainability first principle and states that sustainability means we make decisions and take actions that ensure a healthy environment, vibrant communities and economic vitality for current and future generations. Under this definition, activities related to economic development contribute to the sustainability of the City.

Economic Impact

Financial obligations related to undertake a Cooperation Agreement(s) and/or a Memorandum of Understanding(s) are part of the normal course of business for the Economic Development and Cultural Services Department and are included in the department's annual operating budget. However, as site location selection and processes advance, future travel to China may be required by the Mayor and/or Members of Council and staff to effectively compete for the final site location. If future travel is required, it is anticipated that the costs associated will be allocated to the department's 2017/2018 operating budget.

Communications Plan

A communications plan is not required.

<u>Purpose</u>

The purpose of this addendum report is to obtain Council authority to enter into any necessary Cooperation Agreement(s) or Memorandum of Understanding(s) as generally required by a foreign government with travel visa requirements for the continued support of the City's Economic Development Services.

Background - Analysis and Options

The City of Vaughan's 10-year Economic Development Strategy: *Building a Gateway to Tomorrow's Economy* identifies international business development as a critical factor in improving the City's competitiveness. The key objectives of the international business development program are:

- To support local economic development by providing local businesses with additional tools to access new markets, achieve growth and retain their competitive edge.
- To support local economic development by pursuing foreign investment,
- To create and leverage opportunities arising from multicultural and ethnic partnerships.
- To enhance Vaughan's global image.

China and Vietnam are markets that Ontario seeks to diversify in

Over the past two decades, China has made tremendous strides in becoming a strong global economy with opportunities in a multitude of industry sectors. In fact, China is now the second largest economy and Ontario's second largest single-country trade partner. With trade increasing by more than 200 percent in the past decade, China has become the third largest export destination for Ontario-made products.

Similarly, Vietnam is becoming an increasingly valuable trading partner to Ontario in Southeast Asia with trade increasing to \$3.1 billion in 2016. GDP growth per capita in Vietnam is one of the fastest, at 6.7 percent in 2015. A feasibility study was initiated in August 2016 to consider a free trade agreement with ASEAN countries. Vietnam is part of ASEAN – Association of Southeast Asian Nations.

Staff have been working with a Chinese business entity and a Canadian/Chinese Investor to establish the business' North American 'site' in Vaughan. Vaughan has been "short-listed" as a preferred location.

It is anticipated that a cooperation agreement will require the City to:

- 1. Provide Economic Development Services with respect to location assistance.
- 2. Make introductions to key sector stakeholders and provide assistance in forging agreements with the key stakeholders.
- 3. Prepare a formal invitation for key executives of the Chinese business entity to travel to Vaughan as required by Chinese Visa requirements.
- 4. Acknowledge that additional travel to the Headquarters of the Chinese business entity may be required.

Business Travel between China and Canada requires a Chinese travel Visa

To continue to compete for the North American location of Chinese businesses, Chinese business leaders are required to apply for a travel visa from the Chinese government. The travel visa process is very prescriptive and requires that each person travelling identify what city(s) in which they will be conducting business and the duration of the travel in each city. The visa process is only initiated when a formal invitation from the City's highest ranking official where travel will occur has been submitted.

Opportunities for Vaughan

Ontario has strong cultural and business connections with China, with a large and active Chinese community of more than 713,000 Ontarians of Chinese-origin and 57,570 Chinese students. These cultural and economic ties are also growing in Vaughan where Mandarin is now the fourth most spoken mother tongue, Cantonese is ranked seventh according to the 2016 Census. The number of people identifying Mandarin as their mother tongue jumped from 18th place in 2011 to the 4th spot in 2016 – a 254 percent increase over the five-year period.

Although Chinese businesses continue to explore North American markets for investment and trade opportunities, Vaughan must also take a more assertive approach to seek new export markets, and economic ties.

In 2015 and 2016 Vaughan hosted 13 incoming delegations from China. In addition, Staff have successfully partnered with the Jiangsu International Business Association of Canada (JSIBAC) to host an annual Canada-China Free Trade Agreement Forum at Vaughan City Hall which included attendance by the Consulate General of the People's Republic of China in Toronto and the Canada China Chamber of Commerce.

Relationship to Term of Council Service Excellence Strategy Map (2014-2018)

This report is consistent with the Term of Council Service Excellence Strategy Map:

- Attract investment and create jobs.
- Support and promote arts, culture, heritage and sports in the community
- Facilitate the development of the VMC

Regional Implications

If Vaughan became the preferred location for a Chinese business, there would be a positive economic impact to the Region and the Greater Toronto Area.

Conclusion

International business development plays an important role in creating and maintaining a vibrant local economy. A sustained presence in the Chinese market, backed by the provincial government, gives Vaughan additional access to government and business officials that will continue to foster international business development opportunities.
