BY-LAW NUMBER 130-2013

A By-law to restrict the weight of vehicles passing over a bridge in the City of Vaughan.

WHEREAS Section 123(2) of the Highway Traffic Act, R.S.O. 1990, Ch.8 as amended provides that the municipal corporation or other authority having jurisdiction over a bridge may by by-law limit the gross vehicle weight of any vehicle or class thereof passing over such bridge, and the requirements of subsection (1) with respect to the posting of notice apply thereto:

AND WHEREAS it is deemed expedient to limit the weight of vehicles passing over the following bridge in the Corporation of the City of Vaughan;

NOW THEREFORE the Corporation of the City of Vaughan ENACTS AS FOLLOWS:

- No vehicle or combination of vehicles or any class thereof, whether empty or loaded, shall be
 operated over the bridge known as Humber Bridge Trail Bridge (Bridge No. 008601) located on
 Humber Bridge Trail, 0.4 km east of Highway 27 in the City of Vaughan where:
 - a) the gross weight exceeds 5 tonnes.
- 2. Any person violating the provisions of this by-law shall be subject to the penalties provided in Section 125 of the Highway Traffic Act.
- This By-law shall not become effective until a notice of the limit of weight permitted in compliance with the regulations under the Highway Traffic Act has been posted in a conspicuous place at each end of the bridge(s).

This by-law remains in force until December 31, 2015.
