BY-LAW NUMBER 164-2015

A By-law to amend By-law 102-2015.

NOW THEREFORE, The Council of the Corporation of the City of Vaughan ENACTS AS FOLLOWS:

1. That By-law No. 102-2015 be amended by deleting Attachment #1 attached thereto and replacing it with Attachment #1 attached hereto, hereby authorizing the following changes:

- Item #1 Removal of Fee Simple Interest Requirement being Part 2 on 65R-34485, consisting of 10.76 square feet (1.0 square metre);
- Item #2 Reference Plan number changed from 65R-35386 to 65R-34485;
- Item #4 Change from Temporary Easement Part 11 to Part 10.

1. 2910 Highway #7 West
Temporary Easement Requirement: Part 1 on Plan 65R-35386, consisting of 322.93 square feet (30.0 metres square).
2. Highway #7, North West Corner of Keele Street
Fee Simple Interest Requirement: being Part 2 on 65R-34485, consisting of 1057.05 square feet (98.2 square metres).
Temporary Easement Requirement: Part 1 on Plan 65R-334485, consisting of 1135.63 square feet (105.5 metres square).
3. Highway #7, at Sylvan Brook Avenue
Fee Simple Interest Requirement: being Part 10 on 65R-34915, consisting of 215.28 square feet (20.0 square metres).
Temporary Easement Requirement: Part 2 on Plan 65R-34915, consisting of 96.88 square feet (9.0 metres square).
4. Located between 1450 and 1438 Centre Street, Part of 20 foot lane
Fee Simple Interest Requirement: Part 11 on Plan 65R-34917, consisting of 430.80 square feet (40 metres square);
Temporary Easement Requirement: described as Part 10 on Plan 65R-34917, consisting of 630.30 square feet (63.2 metres square).
5. Centre Street at King High Drive, Part of a 15 foot lane
Fee Simple Interest Requirement: Parts 24 and 26 on Plan 65R-34945 being 236.81 square feet (22.0 metres square);
Temporary Easement Requirement: Part 25 on Plan 65R-34945, consisting of 150.70 square feet (14.0 metres square);
6. Centre Street, at Loudon Crescent
Fee Simple Interest Requirement: Parts 18 on 65R-34945, consisting of 1,013.99 square feet (94.2 metres square);
Temporary Easement Requirement: Part 19 on 65R-34945, consisting of 1,597.42 square feet (148.4 metres square).
7. West side of Bathurst Street, north of Highway #7
Fee Simple Interest Requirement: Part 1 on Plan 65R-35613, consisting of 1,930.03 square feet (179.3 metres square).
Temporary Easement Requirement: Part 2 on Plan 65R-35613, consisting of 5,637.24 square feet (523.27 square metres square).

8. 1 Promenade Circle (Part of the Transit Hub Location)

Fee Simple Interest Requirement: Parts 10 and 11 on Plan 65R-35019, consisting of 2,421.96 square feet (225 square metres).

Permanent Easement Requirement: Part 12 on Plan 65R-35019, consisting of 215.28 square feet (20.0 square metres).

Temporary Easement Requirement: Parts 13 and 14 on Plan 65R-35019, consisting of 11,033.37 square feet (1,025 square metres);
