BY-LAW NUMBER 169-2017

A By-law to amend the Consolidated Traffic By-law 284-94 as amended, to govern and control traffic in the City of Vaughan.

The Council of The Corporation of the City of Vaughan ENACTS AS FOLLOWS:

1. THAT City of Vaughan By-law 284-94 as amended, be and is hereby further amended by adding the following provision to Schedule "E", Part 1:

SPEED LIMIT	<u>STREET</u>	DESCRIPTION
40 km/h	Millway Avenue	Portage Parkway to Regional Road 7

2. THAT City of Vaughan By-law 284-94, be and it is hereby further amended by adding the following provisions to schedule "F", Part 2:

HIGHWAY / INTERSECTION	<u>DIRECTION</u> TURN	PROHIBITED	TIME / DAY	EXCEPTION
Millway Avenue from Portage Parkway to Regional Road 7	Northbound	"U"	Anytime	None
Millway Avenue from Portage Parkway to Regional Road 7	Southbound	"U"	Anytime	None
Millway Avenue and Bus Terminal Driveway	Northbound	Left	Anytime	Bus Excepted
Milway Avenue and Bus Terminal Driveway	Southbound	Right	Anytime	Bus Excepted

- 3. THAT City of Vaughan By-law 1-96, as amended, be further amended as follows:
 - (a) Add the following sections:
 - 5(7.1) Despite Section 5(7) and Schedule A, Part 13, no person shall shall park or stop a vehicle at any time on the west side of Millway Avenue, between the limits of 15 metres south of Applemill Road and 9 metres north of New Park Place, with the exception of authorized

public transit vehicles or vehicles under contract therewith to provide passenger transportation services.

- 5(7.2) Despite Section 5(7) and Schedule A, Part 13, no person shall park or stop a vehicle at any time on the north side of New Park Place, between the limits of 9 metres west of Millway Avenue and 16 metres west of Millway Avenue, with the exception of vehicles with a valid Permit and vehicles used primarily for the conveyance of passengers with disabilities, including accessible taxicabs and paratransit, which may stop to a maximum of ten minutes any time for purposes of picking up or dropping passengers with accessibility needs.
- (b) Amend Schedule "A" Part 10, Parking Infraction Table for Administrative Penalties, by adding the following infractions, as follows:

36	Stop or park in an area designated for public transit	\$ 100
37	Stop or park in an area designated for accessible vehicles	\$ 300

(c) Add the following in alphabetical sequence to Schedule "A" Part 13, Parking Permitted – 10 Minutes maximum, as follows:

HIGHWAY SIDE FROM AND TO PROHIBITED TIME OF DAY

New Park Place South From 9 metres west of Millway Anytime

Avenue to 42 metres west of

Millway Avenue

This By-law comes into effect once all lands described hereinabove are dedicated as public highway.
