MEMORANDUM OF ORAL DECISION DELIVERED BY JASON CHEE-HING AND RICHARD MAKUCH ON FEBRUARY 5, 2013 AND ORDER OF THE BOARD

- [1] This is the second pre-hearing conference ("PHC") of these proceedings. Attachment 1 provides the list of parties and their representatives that were in attendance at this PHC. Attachment 2 contains an updated list of appellants, parties who are not appellants, and participants.
- [2] The City of Vaughan ("City") provided a status update with respect to the appellants, non-appellant parties, and participants' submissions to the City as it relates to the scoping of its appeals and related submissions. Claudia Storto, counsel for the City advised that not all appellants/parties have submitted or only partially submitted its scoped submissions to the City. The Board directs that all appellants/parties contact Ms. Storto to verify that their submissions are complete. The City recommended certain

timelines for the receipt, review and compilation of these submissions. The Board adopts these timelines as follows:

- 1. Appellants/Parties are to identify their interests and positions to the City no later than February 19, 2013.
- 2. City will compile and circulate this information by February 26, 2013.
- 3. Any concerns regarding the status of any non-appellant party be communicated to the City in writing by March 5, 2013.
- [3] Ms. Storto advised that additional requests have been made by a number of entities for either party or participant status at these proceedings. These requests will be dealt with at the next PHC.
- [4] Michael Melling advised that his client, the Vaughan 400 North Landowners Group Inc. has requested a change to its current participant status to party. The City wants an opportunity to review this request and will make its concerns known (if any) at the next PHC. The Board will review its status at the next PHC.
- [5] Both Ira Kagan and Barry Horosko advised the Board that they represent a number of appellants at these proceedings and wanted assurance that those non-appellant parties (either confirmed or yet to be confirmed by the Board) state their positions clearly. Particularly, whether they are challenging or supporting the Vaughan Official Plan (OP) under appeal. If they are challenging certain portions of the OP then which appeals are they sheltering under? The Board directs that those non-appellant parties state their positions including which appeals they have concern with in writing to the City.
- [6] The City advised that a number of appellants whose appeals relate to the West Vaughan Employment Secondary Plan have expressed a desire for board led mediation. The City is also requesting mediation with respect to these appeals and also advised that going forward they may be requesting mediation for other appeals of its OP. There are currently 112 appeals of the 2010 Vaughan OP. The Board encourages mediation as a mechanism for resolving issues/concerns and directs that those appellants interested in mediation contact the Board's case coordinator (Mr. Ryan Co) forthwith.

[7] James Harbell, counsel for Bentall Kennedy (Canada) LP has by motion requested party status for his client. The City advised that they are in discussions with Mr. Harbell and requests that this matter be dealt with at the next PHC. Mr. Harbell did

not object. The Board will address this motion at the next PHC.

[8] Steven Zakem, counsel for the appellants, Granite and Magna, advised that the motion for consolidation has been put off at this time. On behalf of the moving parties (Granite, Magna and CN), he is requesting that should the motion be brought back, that only those entities requesting future motion materials be served. All parties have been advised of Mr. Zakem's request. The Board considered and granted this request.

[9] The next PHC is set down for May 28, 2013, commencing at 10 a.m. The venue is to be determined by the City. The City will inform the parties and participants of the venue by e-mail. No further notice of the next PHC is required.

[10] This panel of the Board will continue with the case management of these appeals.
