MEMORANDUM OF ORAL DECISION DELIVERED BY J. de P. SEABORN AND S. TOUSAW ON JULY 11, 2017 AND ORDER OF THE BOARD

2 PL111184

- [1] The matter before the Board is a further pre-hearing conference ("PHC") scheduled in connection with the City of Vaughan Official Plan ("VOP") 2010. Notice of the PHC was given in the Board's previous disposition, issued May 24, 2017.
- [2] Mr. Engell provided a brief agenda for the PHC, revised exhibit list and updated the Board with respect to the status of the various groups of appeals (164 in total). A chart was provided that groups the various appeals, the majority of which are either resolved or were previously hived off and are being adjudicated through separate hearing processes. The appeals relating to the parkland policies are on hold and for the other groups of appeals, PHC's or hearing dates have been set. There is a group of appeals (referred to as "other development applications") where the resolutions will be reflected in the VOP once settlements are reached and/or hearings held and decisions are issued. That leaves a group of 22 appeals referred to as "other site specific appeals" that remain the focus of this PHC process.
- [3] With respect to this remaining group of "other site specific appeals", Mr. Engell explained that these appeals that are not City-wide, a secondary plan is not involved and development applications have not been filed. The City is proposing to use the summer and early fall to address these appeals. Staff reports will be prepared and any settlements will go to City Council and presented to the Board for a decision at the next PHC. There were no objections from Counsel who appeared with respect to the City's proposal. Mr. Heisey, who represents Appeal #141 and Canadian National Rail ("CNR", a party) indicated that while he was not seeking any relief from the Board, it is important that his client's issues be resolved as quickly as possible especially as they relate to the CNR lands and he may revisit the matter at the next PHC.
- [4] Finally, while there may be some additional appeals, the Regional Municipality of York has issued a notice (dated June 23, 2017) limiting the appeal period pursuant to the provisions of s. 17(41.1) of the *Planning Act*. The notice explains that the last date of appeal is July 13, 2017 and direction on how to appeal is included as part of that notice. The City provided an updated list of all Appellants, Parties and Participants (as of July

11, 2017) including their respective representatives which is set out as Attachment 1 to this decision.

[5] At the request of the City with the consent of the parties who attended the hearing, the next PHC is scheduled to commence at 10 a.m. on Thursday, November 23, 2017 at:

City of Vaughan, Municipal Building, Multi-Purpose Room, 2141 Major Mackenzie Drive Vaughan, ON L6A 1T1

There shall be no further notice. Given the complexities earlier in the process, the Board had imposed longer periods for service of motion materials. These requirements are no longer necessary and motions may be made in the normal course and in accordance with the Board's *Rules of Practice and Procedure*. If there are any settlements on consent that can be addressed in writing prior to the next PHC, the requisite affidavit and draft Order may be filed with the Board and thereafter a decision will issue.

[6] If any difficulties arise prior to the next PHC, the Case Coordinator may be contacted and a telephone conference call arranged.
