## Environmental Assessment Study Kirby Road Extension between Dufferin Street and Bathurst Street City of Vaughan

Rizmi Holdings Limited (RHL) authorized by the City of Vaughan is undertaking an Environmental Assessment Study (EA Study) to establish the preferred alignment and design for the extension of Kirby Road between Dufferin Street and Bathurst Street.

The EA Study is conducted as a Schedule 'C' Municipal Road Project in accordance with the current Municipal Engineers Association Municipal Class Environmental Assessment process. The EA Study takes into account findings of the City of Vaughan Transportation Master Plan (2013) and the Regional



Municipality of York Transportation Master Plan (2016). Both plans completed Phases 1 and 2 of the EA process and confirmed the need for Kirby Road extension. The approximate study area limits are shown on the map to the left.

The EA process adapted for the EA Study includes: consultation with and review public agencies; screening and evaluation alternative road alignments and design concepts; assessment and mitigation of potential effects of the proposed Kirby Road extension on the environment; preparation of an Environmental Study Report (ESR) that will document the study process and identify the preferred alignment and design for the extension of Kirby Road.

At the conclusion of the EA Study, the ESR will be provided to the City of Vaughan. The City will then determine whether or not to issue a Notice of Study Completion as a co-proponent and file the ESR for public review.
