MEMORANDUM OF ORAL DECISION DELIVERED BY S. TOUSAW ON JANUARY 15, 2021 AND ORDER OF THE TRIBUNAL

- [1] This Motion hearing was held to consider the City of Vaughan's ("City") Motion seeking to hear site-specific Official Plan Amendment ("OPA") appeals within the south area of the Yonge Steeles Corridor Secondary Plan ("YSCSP") together with appeals of the YSCSP.
- [2] The Motion Record, the Responding Records, and the Parties' email correspondence in lieu of a Responding Record, as filed with the Tribunal, were marked as Exhibits.
- [3] Based on the affidavit of David Marcucci, Registered Professional Planner with the City and previously qualified in these proceedings, the City suggests that the overlap of planning issues raised by the site-specific appeals and by the YSCSP appeals, if heard together, will result in a more efficient hearing and enable a consistent planning approach within this area surrounding a future subway station. Mr. Marcucci explains that the site-specific proposals themselves exceed the population and density expectations of the YSCSP under appeal.
- [4] The City requests to hear five site-specific OPAs with the YSCSP hearing. Not all of these files have been appealed by their respective proponent and assigned a file number at the Tribunal, although each supports the Motion, noting that appeals will be filed in the near future.

[5] The site-specific proponents ("Applicants") and Appellants have no objection to the Motion provided that should circumstances change, they retain the right to request their appeal to be separated from the YSCSP, with such separation determined by the Tribunal. The City agreed that it would evaluate such requests on their merits without arguing that this Motion precludes such consideration.

- [6] Parties to the YSCSP who have not yet filed development applications advised that they would like the same opportunity to be combined with the YSCSP should appeals be lodged.
- [7] With consent of the affected Applicants, Appellants and Parties, the Tribunal granted the City's Motion request 1(b) as follows: that appeals to site-specific OPA applications within the south area of the YSCSP, as listed on Attachment 2, be heard together with the appeals of the YSCSP.
- [8] The Tribunal finds that the efficiency and fairness resulting from combining the hearings are confirmed by the support of the affected Applicants, Appellants and Parties. Although the Tribunal has no jurisdiction over any site-specific OPAs that are not under appeal, those included in Attachment 2 have consented to their inclusion, and should they lodge appeals, this Decision will provide guidance to the Tribunal to administer their hearings with the YSCSP. An affected site-specific Appellant may request the Tribunal to consider separating it from the combined hearing should they feel that new circumstances warrant. Other site-specific OPA appeals that arise within the YSCSP south area may be considered at a future Case Management Conference ("CMC") for inclusion in a combined hearing at the request of the Parties.
- [9] The City withdrew its Motion requests 1(a) and 1(c). As directed in the Tribunal's Decision issued December 11, 2020, the scheduling of the combined hearing for the YSCSP will be considered at a future CMC based on a hearing plan, Issues List and Procedural Order to be drafted by the Parties.
