Notice of Commencement Municipal Class Environmental Assessment Study

McNaughton Road West Widening and Urbanization from Major Mackenzie Drive to Falvo Street

The Study

The City of Vaughan has initiated a Schedule 'C' Municipal Class Environmental Assessment (EA) for improvements to McNaughton Road West between Major Mackenzie Drive and Falvo Street. The study will assess the urbanization and widening of McNaughton Road West from two to four lanes, the inclusion of sidewalks, cycling facilities and mid-block and trail crossings as needed to support the proposed connection to the proposed Vaughan Super Trail and Bartley Smith Greenway Trail. These improvements will address the capacity and operational needs to accommodate planned growth in the area for pedestrians, cyclists, transit users and motorists.



The Process

This study will carry out Phases 1 through 4 of the Municipal Class EA process and will assess the proposed improvements with consideration of impacts on transportation services and the natural, socio-economic and cultural environments. The study will be completed in accordance with the planning and design process for Schedule 'C' projects, as outlined in the Municipal Engineers Association Municipal Class EA guidelines (October 2000, as amended in 2007, 2011 and 2015). Upon completion, an Environmental Study Report will be made available for public review and comment. The report will document the study, consultation process and decision-making rationale.

Consultation

Consultation with citizens is a key component of this study. The City will engage and collaborate with stakeholders to learn, educate and discuss possible ways to improve transportation choices in the area to create a more sustainable and transportation-oriented future.

Two Public Information Centres will be held throughout the study process to present findings, share alternative designs, evaluations and recommendations for review and comment.
