

NOTICE OF PUBLIC MEETING:

Weston 7 Transportation Master Plan & Secondary Plan



The City of Vaughan is holding a virtual Public Meeting to discuss both the Weston 7 Transportation Master Plan and Secondary Plan.

TRANSPORTATION MASTER PLAN STUDY AND PROCESS

The Transportation Master Plan (TMP) will help to define the transportation network for all modes of travel to meet future travel needs. Using a fully integrated and holistic approach to transportation and land use planning, the TMP study is concurrently being undertaken with the Secondary Plan study in the development of a long-range transportation plan. The TMP will include a multi-modal transportation network, new policies, and a phasing strategy for improved accessibility and connectivity. It will also inform transportation planning and the policy framework in the Secondary Plan. A key plan showing the study area can be found on the reverse of this notice.

The Study is being carried out in accordance with Master Plan Phases 1 and 2 of the Municipal Class Environmental Assessment process (MCEA, as amended in 2015), which provides municipalities with a framework for the planning, design, and implementation of municipal infrastructure.

SECONDARY PLAN STUDY

This TMP is being carried out concurrently with the Weston 7 Secondary Plan, for which an Open House is also being held as part of this virtual meeting. The Secondary Plan will guide future growth, as well as the transformation of the area into a distinct urban setting with a variety of commercial, cultural, and entertainment destinations. It will additionally provide housing options and employment opportunities within walking distance to the Highway 7 Rapidway and other nearby transit options.

WE WANT TO HEAR FROM YOU

Consultation is a key component of both the Secondary Plan and TMP. Following completion of Secondary Plan Phase 1 and the TMP Notice of Commencement, this meeting is being jointly held to: introduce you to the TMP study; provide you with an opportunity to review the information on the existing conditions analysis and preliminary future conditions; and collect input on identifying opportunities, challenges, and ideas for the future transportation vision of Weston 7.
