Weston 7 Transportation Master Plan

THE STUDY

The City of Vaughan is undertaking the Weston 7 Transportation Master Plan (TMP) study for the Weston 7 Secondary Plan area, to develop a long-range transportation plan that accommodates many forms of transportation, including walking, cycling, transit and driving. Once complete, the TMP will recommend a transportation network and outline an implementation strategy for future projects that will address connectivity, growth, accessibility and mobility for all modes of transportation for the Weston 7 area.

THE PROCESS

The study is being conducted in accordance with the requirements for Phases 1 and 2 of the Municipal Class Environmental Assessment (2023), which is an approved process under the *Ontario Environmental Assessment Act*.

Public consultation is a key component of the study process. Public Information Centre was held in November 2021 to introduce the study, provide information on the existing and future conditions and to collect feedback on identifying opportunities, challenges, and ideas for the future transportation vision of the Weston 7 Secondary Plan area.
