

Application Form: Mobile Sign Permit on Public Space for Use by a Religious, Community or Charitable Organization

This form allows religious, community or charitable organizations to apply to a use a mobile sign permit on one of several public spaces listed on this form, in line with the Sign By-law, as amended, posted in the City of Vaughan's By-law Library at www.vaughan.ca/bylaw. How to apply

Applicants can complete this form and submit it via email to City of Vaughan staff at nonprofitmobilesigns@vaughan.ca. There is no cost to submit this form. Staff will follow up within 5 business days to confirm if the permit has been granted.

Conditions of the permit

If the permit is granted, the permit holder is responsible for adhering to the following conditions for the approved permit space:

- The permit holder must provide the mobile sign.
- Only one sign is allowed per event by organization, which can be displayed for a maximum of 30 days.
- Signs can be displayed up to 30 days before an event and must be removed thereafter.
- The sign can be up to 4.4 square metres in size (48 square feet), can be up to 2.5 metres high and can display information on both of its two sides.
- Signs may **not**:
 - o have any parts that are flashing, moving, or illuminated;
 - use the terms Stop, Look, One Way, Danger, Yield or any similar words used for traffic signs;
 - be placed within 3.0 metres of a driveway, in a sight triangle or other location that may block the view of a motorist, such as when exiting or entering a driveway; and
 - o be located within a minimum of 22 metres (72 feet) of any other sign.
