TECHNICAL AMENDMENTS REPORT ON THE BUSINESS LICENSING, FENCE, PARKING, ANIMAL CONTROL, WATER USE, SEWER USAGE AND FEES AND CHARGES BY-LAWS

## COMMITTEE OF THE WHOLE (2) – February 13, 2024

On February 13, 2024, the City of Vaughan Committee of the Whole (2) will consider and receive input from the public on a staff report that proposes to amend the City's Business Licensing, Fence, Parking, Animal Control, Water Use, Sewer Usage and Fees and Charges By-laws with respect to the following:

### In the Business Licensing By-law:

• to clarify the application and renewal requirements for various licences and permits (including certified translation and identification requirements).

### In the Fees and Charges By-law:

to correct the fees that were incorrectly updated as part of the budget update process.

### In the Fence By-law:

 to clarify that swimming pool enclosures must be completely located on the pool owner's property or property line, and to add additional wording to clarify which provisions apply to such enclosures.

### In the Parking By-law:

• to update parking provisions in line with the Zoning By-law, to allow commercial vehicles to park on residential lots.

# In the Animal Control By-law:

• to correct references to outdated by-laws within Animal Control By-law, as well as to clarify that pet licensing fees are non-refundable.

### In the Water Use By-law:

to standardize formatting of the existing by-law and to replace it with a new one.

# In the Sewer Usage By-law:

• to standardize formatting of the existing by-law and to replace it with a new consolidated one.
