BY-LAW NUMBER 052-2024

A By-law to amend the Consolidated Traffic By-law 284-94, as amended, to govern and control traffic in the City of Vaughan.

WHEREAS By-law 284-94 of The Corporation of the City of Vaughan, as amended, regulates traffic on roads under the jurisdiction of the City of Vaughan;

AND WHEREAS amending by-laws may be enacted from time to time by the Council of The Corporation of the City of Vaughan, changing the traffic regulations on the road under its jurisdiction;

AND WHEREAS the Council of the Corporation of the City of Vaughan deems it appropriate to further amend Traffic By-law 284-94, as amended;

NOW THEREFORE the Council of The Corporation of the City of Vaughan ENACTS AS FOLLOWS:

1. THAT City of Vaughan By-law 284-94, as amended, be further amended by adding the following provisions to Schedule "E", Part 1:
