# *BY-LAW*

## **BY-LAW NUMBER 105-2024**

**A By-law to enact the three phased temporary road closure of Grand Trunk Avenue and Muret Crescent.**

**WHEREAS** as its meeting of June 25<sup>th</sup>, 2024, pursuant to the Municipal Act, 2001, the Council of the City of Vaughan approved the three phased temporary road closure on Grand Trunk Avenue and Muret Crescent; for the installation of vital infrastructure to support the development of residential homes in vacant blocks within Block 18;

**AND WHEREAS** the lands which are situate in the City of Vaughan, Regional Municipality of York, on Muret Crescent, between Grand Trunk Avenue and Savona Place, the first phase of the closure, will be closed temporarily from July 2nd to July 23rd, 2024;

**AND WHEREAS** the second phase of the temporary closure will take place on Grand Trunk Avenue, between Barletta Drive and Sand Valley Road from July 24th to July 31st, 2024;

**AND WHEREAS** the third phase of the temporary closure will take place on Grand Trunk Avenue, between Sand Valley Road and 100m north of Sand Valley Road; from July 24th to July 31st, 2024;

**NOW THEREFORE** the Council of The Corporation of the City of Vaughan ENACTS AS FOLLOWS:

1. THAT the first phase of the temporary closure on Muret Crescent, between Grand Trunk Avenue and Savona Place, as per Schedule "A", be and is hereby closed temporarily from July 2nd to July 23rd, 2024.
2. THAT the second phase of the temporary between Barletta Drive and Sand Valley Road as per Schedule "A", be and is hereby closed temporarily from July 24th to July 31st, 2024.
3. THAT the third phase of the temporary closure on Grand Trunk Avenue, between Sand Valley Road and 100m north of Sand Valley Road; as per Schedule "A", be and is hereby closed temporarily from July 24th to July 31st, 2024.

Voted in favour by City of Vaughan Council this 25<sup>th</sup> day of June, 2024.

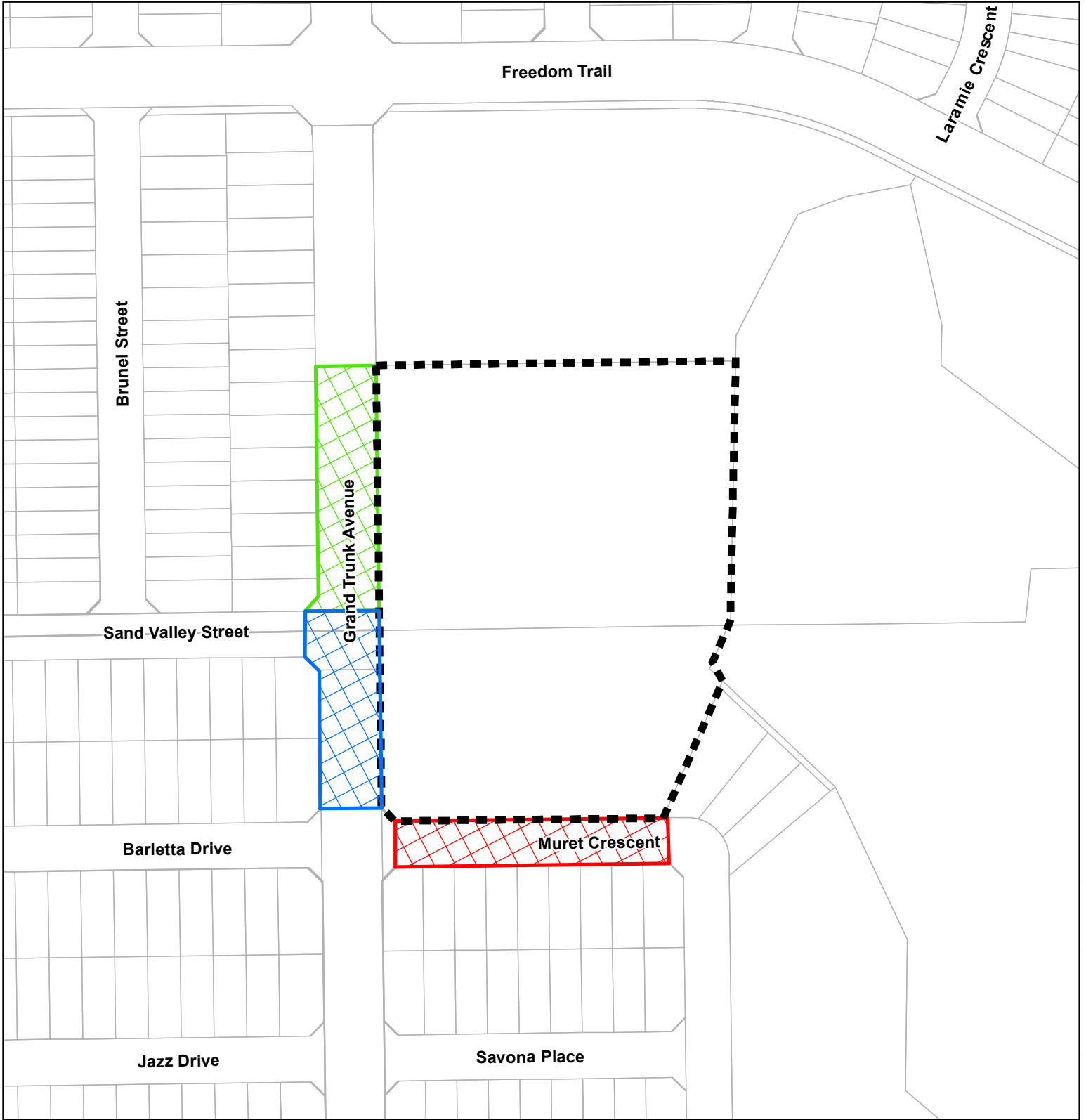
