BY-LAW NUMBER 016-2025

A By-law to dedicate certain lands as part of the public highway.

WHEREAS Section 31 of *the Municipal Act, 2001, SO 2001, c.25* confers that land may only become a highway by virtue of a by-law establishing the highway and not by the activities of the municipality or any other person in relation to the land.

NOW THEREFORE the Council of The Corporation of the City of Vaughan ENACTS AS FOLLOWS:

1. THAT the lands which are situated in the City of Vaughan, in the Regional Municipality of York, being Reserve Block 210, on Plan 65M-4657 and Reserve Block 193, on Plan 65M-4694, registered in the Land Registry Office for the Land Titles Division of York Region (No.65); be and they are hereby dedicated as part of public highway known as “Winthrop Crescent”.
2. THAT the lands which are situated in the City of Vaughan, in the Regional Municipality of York, being Reserve Block 211, 212, 213, 219, on Plan 65M-4657, and Reserve Block 192 on Plan 65M-4694, registered in the Land Registry Office for the Land Titles Division of York Region (No.65); be and they are hereby dedicated as part of public highway known as “Ballantyne Boulevard”.
3. THAT the lands which are situated in the City of Vaughan, in the Regional Municipality of York, being Reserve Block 216, on Plan 65M-4657, and Reserve Block 91 and 92, on Plan 65M-4701 registered in the Land Registry Office for the Land Titles Division of York Region (No.65); be and they are hereby dedicated as part of public highway known as “Greville Street”.
4. THAT the lands which are situated in the City of Vaughan, in the Regional Municipality of York, being Reserve Block 217 and 218, on Plan 65M-4657, registered in the Land Registry Office for the Land Titles Division of York Region (No.65); be and they are hereby dedicated as part of public highway known as “Heathcote Road”.

5. THAT the lands which are situated in the City of Vaughan, in the Regional Municipality of York, being Reserve Block 220, on Plan 65M-4657, registered in the Land Registry Office for the Land Titles Division of York Region (No.65); be and they are hereby dedicated as part of public highway known as “Campacci Crescent”.
6. THAT the lands which are situated in the City of Vaughan, in the Regional Municipality of York, being Reserve Block 222, on Plan 65M-4657, registered in the Land Registry Office for the Land Titles Division of York Region (No.65); be and they are hereby dedicated as part of public highway known as “Pickford Street”.
7. THAT the lands which are situated in the City of Vaughan, in the Regional Municipality of York, being Reserve Block 224, on Plan 65M-4657, registered in the Land Registry Office for the Land Titles Division of York Region (No.65); be and they are hereby dedicated as part of public highway known as “Tilden Street”.
8. THAT the lands which are situated in the City of Vaughan, in the Regional Municipality of York, being Reserve Block 90, on Plan 65M-4701, registered in the Land Registry Office for the Land Titles Division of York Region (No.65); be and they are hereby dedicated as part of public highway known as “Adario Crescent”.
9. THAT the lands which are situated in the City of Vaughan, in the Regional Municipality of York, being Reserve Block 10, on Plan 65M-4702, registered in the Land Registry Office for the Land Titles Division of York Region (No.65); be and they are hereby dedicated as part of public highway known as “Costain Crescent”.
10. THAT the lands which are situated in the City of Vaughan, in the Regional Municipality of York, being Reserve Block 135, on Plan 65M-4732, Reserve Block 190 and 191, on Plan 65M-4694 and Part 1 as shown on Registered Plan 65R-38848, registered in the Land Registry Office for the Land Titles Division of York Region (No.65); be and they are hereby dedicated as part of public highway known as “Rideout Court”.
