BY-LAW

BY-LAW NUMBER 094-2025

A By-law of the Corporation of the City of Vaughan to amend Fees and Charges By-law 251-2024, as amended, to make changes to refreshment vehicle licensing and renewal fees and to create a new permit fee for refreshment vehicles operating on City property.

WHEREAS Section 8(1) of the *Municipal Act*, 2001, S.O. 2001, c. 25, as amended, (“*Municipal Act*”) provides that the powers of a municipality shall be interpreted broadly as to confer broad authority on a municipality to (a) enable it to govern its affairs as it considers appropriate, and (b) enhance its ability to respond to municipal issues;

AND WHEREAS Section 11(2) of the *Municipal Act* provides that a lower-tier municipality may pass by-laws respecting health, safety and well-being of persons and protection of persons and property, including consumer protection;

AND WHEREAS Section 11(3) of the *Municipal Act* provides that a lower-tier municipality may pass by-laws respecting business licensing;

AND WHEREAS Section 391 of the *Municipal Act* provides for the municipality to impose fees or charges on persons for services or activities provided or done by or on behalf of it;

AND WHEREAS the Council of The Corporation of the City of Vaughan has determined that it is desirable to make amendments to By-law 251-2024, as amended;

NOW THEREFORE the Council of the Corporation of the City of Vaughan ENACTS AS FOLLOWS:

1. To amend Schedule N of the Fees and Charges By-law 251-2024, as amended, by deleting the current fees for “Refreshment Vehicles Driver”, “Refreshment Vehicles Owner Type 1/2” and “Refreshment Vehicles Owner Type 3” and to replace them with the following:
