# ***BY-LAW***

## **BY-LAW NUMBER 196-2025**

**A By-law to amend By-law 144-2018 to delegate administrative authority to the Director of By-law and Compliance, Licensing and Permit Services to approve and execute agreements pertaining to parking enforcement on private property, and Animal Services related matters, and to the Deputy City Manager, Community Services, to approve and execute agreements pertaining to Animal Services related matters and to amend By-law 005-2018 to repeal certain existing delegated authorities and transfer them to By-law 144-2018.**

**WHEREAS** subsection 5(3) of the *Municipal Act*, 2001, S.O. 2001, c. 25, as amended (hereinafter the “Municipal Act”), provides that a municipal power shall be exercised by by-law;

**AND WHEREAS** section 23.1(1) of the Municipal Act, authorizes a municipality to delegate administrative powers and duties subject to certain restrictions;

**AND WHEREAS** the Council of the Corporation of the City of Vaughan enacted By-laws 144-2018 and 005-2018 to delegate authority regarding certain matters to staff to improve daily business efficiencies;

**AND WHEREAS** the Council of the Corporation of the City of Vaughan finds it desirable to delegate additional authority to staff as contained herein and amend By-laws 144- 2018 and 005-2018 accordingly;

**NOW THEREFORE** the Council of The Corporation of the City of Vaughan ENACTS AS FOLLOWS:

1. That By-law 005-2018, as amended, be amended by repealing Section 4.
2. That By-law 144-2018, as amended, be amended by adding section “By-law & Compliance, Licensing & Permit Services” to Schedule “A” as follows:
