BY-LAW NUMBER 207-2006

A By-law to amend By-law Number 82-2006, being the Photography Permits By-Law

WHEREAS the Council of The Corporation of the City of Vaughan enacted the Photography Permits By-law on the 20th day of March, 2006, as By-law Number 82-2006;

AND WHEREAS the Council of The Corporation of the City of Vaughan has determined it is appropriate to amend the said By-law Number 82-2006, to remove certain City sites or City owned property and to make other amendments for clarification;

NOW THEREFORE The Council of The Corporation of the City of Vaughan ENACTS AS FOLLOWS:

- 1. By-law Number 82-2006, the Photography Permits By-law, shall be and is hereby amended as follows:
 - (1) by deleting clause 1 (a) and substituting the following therefor:
 - "1 (a) "permit" means any written authorization to conduct, carry out engage in or otherwise perform commercial photography on property under the ownership of the City of Vaughan (hereinafter referred to as "City site" or "sites" or "City owned lands" or "City owned property" in accordance with the terms and conditions of this By-law;"
 - (2) by deleting clause 1 (b) and substituting the following therefor:
 - "1 (b) "City site," "City owned lands" or "City owned lands or property" and like words mean any park, heritage site or other public site in the City of Vaughan that is owned by the City of Vaughan."
 - (3) by adding clause 1 (c) as follows:
 - "1 (c) "commercial photography" and "photography" mean photographs taken or other electronic images taken in the course of performance of a contract by a commercial photographer for a special occasion or event, including but not limited to weddings, graduations, family or other group photographs, and whether or not the contract is arranged with or has been entered into by a resident or a non-resident of the City of Vaughan for such services."
 - (4) by deleting subsection 2 (1) and substituting the following therefor:
 - "2 (1) Any person employed by the City of Vaughan Department of Recreation and Culture is hereby authorized to administer and issue permits for photography on Cityowned lands or property designated by the Department of Recreation and Culture as suitable for commercial photography, including but not limited to the Thoreau

MacDonald House and the Vellore Hall, School and Heritage Square, but excluding the Scout House and Railway Station."

- (5) by deleting the following words at the end of clause 2 (2) (b):
 - "...is authorized to enforce the provisions of this By-law."
- (6) by deleting subsection 3 (8) and renumbering subsections 3 (9) and 3 (10) as 3 (8) and 3 (9) respectively.
- (7) by renumbering subsections 7 (1) and 7 (2) to subsections 7 (2) and 7 (3) respectively;
- (8) by adding subsection 7 (1) as follows:
 - "7 (1) No person shall take one or more commercial photographs, or engage in or perform any commercial photography, on a City site, City owned lands or on City owned property, whether or not the City site is designated as suitable for commercial photography, without first obtaining a photography permit under this By-law and payment of the relevant permit fees."

READ a FIRST, SECOND and THIRD time and finally passed this 26th day of June, 2006.
