 - i) The Owner shall pay to the City of Vaughan by way of certified cheque, cash-in-lieu of the dedication of parkland equivalent to 2% of the value of the subject lands, prior to the issuance of a Building Permit, in accordance with Section 42 of the Planning Act. The Owner shall submit an appraisal of the subject lands prepared by an accredited appraiser for approval by the Vaughan Legal Services Department, Real Estate Division, and the approved appraisal shall from the basis of the cash-in-lieu payment; and,
 - ii) Prior to the issuance of a Building Permit for any development on the subject lands, the Owner shall successfully obtain approval of a Consent Application from the Vaughan Committee of Adjustment to sever the subject lands and create a mutual access easement for the northerly driveway and the Committee's decision shall be final and binding and the Owner shall satisfy all conditions of the Committee.

NEW BUSINESS - EMERGENCY PREPAREDNESS WEEK IN VAUGHAN AND RAIL CARS TRANSPORTING DANGEROUS GOODS

Submitted by Councillor Alan Shefman.

Whereas, this is Emergency Preparedness Week in Vaughan, and

Whereas, this municipality takes the safety of its residents very seriously, and

Whereas, the City of Vaughan maintains a high level of preparedness for its ability to respond to an emergency, and

Whereas, within the City there are two major rail hubs that draw significant amounts of rail traffic travelling through densely populated areas of the municipality, and

Whereas, there are significant concerns being raised by municipalities across Canada with the significant increase in the transportation of dangerous goods, especially crude oil and in light of the Lac Megantic tragedy in 2013.

Therefore be it resolved:

- 1. That this Council calls on the Federal Government, the regulator of rail transportation in Canada, to require that rail cars transporting dangerous goods be routed outside of densely populated urban areas, such as the City of Vaughan;
- 2. That the timetable requiring improved safety features of those rail cars be significantly reduced;
- 3. That information on the goods being transported through municipalities in Canada be provided on a more timely and fulsome basis in order to allow emergency preparedness staff to be able to better respond to an accident; and
- 4. That the motion be forwarded to all MPs in York Region and Richmond Hill, Prime Minister Stephen Harper, The Federal Minister of Transportation, the Chair of York Region, FCM and AMO.
