# AWARD OF TENDER T16-066 ROAD REHABILITATION – SONOMA HEIGHTS AND OTHER AREAS WARDS 1, 2 AND 3

The Committee of the Whole recommends approval of the recommendation contained in the following report of the Deputy City Manager of Public Works and the Director of Infrastructure Delivery, dated May 3, 2016:

### Recommendation

3

The Deputy City Manager of Public Works and the Director of Infrastructure Delivery, in consultation with the Director of Financial Planning and Development Finance & Deputy City Treasurer and Director of Procurement Services recommend:

- 1. That Tender T16-066, Road Rehabilitation Sonoma Heights and Other Areas be awarded to Forest Contractors Ltd, in the amount of \$2,055.507.00, plus applicable taxes;
- 2. That a contingency allowance in the amount of \$205,000.00, plus applicable taxes be approved, within which the Deputy City Manager of Public Works, or his designate is authorized to approve amendments to the contract;
- 3. That a Geotechnical Allowance and Material Testing in the amount of \$50,000.00, plus applicable taxes be approved, to ensure compliance with all applicable standards;
- 4. That the amounts identified in the above recommendations, including all contingency allowances, applicable taxes and administration recovery be funded from Capital Project CD-2015-15, 2016 Road Rehabilitation; and
- 5. That the Mayor and City Clerk be authorized to sign the appropriate documents.

### **Contribution to Sustainability**

An integral part of a sustainable city is effective asset management. Through infrastructure investments, the risk of failure is reduced and system reliability improved, providing optimal service to residents. The proposed rehabilitation of the roads will maximize the return on the City's Capital and operating investments and ensure that an acceptable level of service is maintained for the health and well-being of its citizens.

The rehabilitation of the existing roads by utilizing recycled pavement materials are consistent with Green Direction Vaughan Goal #1: To significantly reduce our use of natural resources and the amount of waste we generate, in particular Objective 1.1 To reduce greenhouse gas emissions and move towards carbon neutrality for the City of Vaughan's facilities and infrastructure.

#### **Economic Impact**

The total project cost of 2,399,494.87 is available within approved Capital Project CD-2015-15, 2016 Road Rehabilitation. A detailed explanation of the funding is provided in the **Background - Analysis and Options** section of this report.

# The Road Rehabilitation for various streets was approved as part of the 2016 Capital Budget

The scope of work as part of this contract includes curb and sidewalk repairs, as well as road rehabilitation in various areas of western Vaughan. (See Attachments Nos. 1-3 for project locations).

# On March 10, 2016, bids were received for T16-066 - Road Rehabilitation – Sonoma Heights and Other Areas

The tender was advertised in the Daily Commercial News, on the Ontario Public Buyers Association (OPBA), Biddingo and the City Bid Opportunities Website on February 25, 2016 and closed on March 10, 2016. A total of 15 sets of bid documents were downloaded from the City website. A total of 11 compliant bids were received:

In accordance with the Contingency Matrix (identified in Appendix 1 of the Capital Project Finance Administration and Reporting Policy), a contingency allowance of 10% has been identified as an appropriate amount to address any unforeseen work in completing the scope of this project. Any residual funds will be used for other phases of the project to be tendered separately.
