Purpose

To provide Council with the revised City of Vaughan Emergency Plan that incorporates recommendations from the Emergency Exercise conducted November 28, 2011.

Background - Analysis and Options

The *Emergency Management and Civil Protection Act* (RSO 1990) and Regulation 380/04 require that every municipality have an emergency response plan and that the plan is reviewed annually and revised as necessary. The Act requires that the municipality adopt the Emergency Plan by By-Law. The Emergency Management Team in the exercise debriefing made recommendations to amend the City's Emergency Plan to enhance our capacity to manage emergencies. The recommendations were approved by the Emergency Management Program Committee. The following recommendations have been included in the 2012 Version of the Emergency Plan:

- 1. Update the roles and responsibilities of the PowerStream Officer
- 2. Add the following technical support positions to the EMT
 - a. Operations Infrastructure Technician
 - b. GIS Technician,
- 3. Add an initial incident briefing process
- 4. Revise notification procedure to ensure equal distribution of Senior Staff on all shifts
- 5. Approval of unbudgeted expenditures

Additional minor changes were made to the document to correct awkward language, reflect operationing procedures with in the Emergency Operations Centre and reflect policies and procedures of the City. A complete list of the revisions are in Attachment 1.
