Item 27, Report No. 43, of the Committee of the Whole, which was adopted without amendment by the Council of the City of Vaughan on December 13, 2016.

27 CYCLING AND PEDESTRIAN ADVISORY TASK FORCE APPOINTMENT

The Committee of the Whole recommends approval of the recommendation contained in the following report of the City Clerk, dated December 6, 2016:

Recommendation

The City Clerk, on behalf of the Cycling and Pedestrian Advisory Task Force, forwards the following recommendation from its meeting of October 13, 2016 (Item 3, Report No. 4):

1. That the Elliott Silverstein be appointed as the CAA representative on the Task Force replacing the previously appointed representative.

Purpose

The purpose of this report is to forward for Council's consideration the recommendation of the Cycling and Pedestrian Advisory Task Force from its meeting of October 13, 2016, that Elliott Silverstein replace Caroline Grech as the CAA representative on the Task Force.

Background - Analysis and Options

Council, at its meeting of January 19, 2016, approved the establishment of the Cycling and Pedestrian Advisory Task Force. The Task Force is responsible for developing recommendations that would allow the City to better integrate cycling and pedestrian perspectives into land use, infrastructure, and resource allocation planning processes along with identifying opportunities for improving cycling and walking conditions in the City.

The Task Force is comprised of citizen representatives and nominees representing various organizations as identified in the Terms of Reference. Correspondence was received from CAA advising that their representative on the Task Force, Caroline Grech, was no longer with the organization and nominating Elliott Silverstein as the CAA representative. At the Task Force meeting of October 13, 2016, members recommended that Council appoint Elliott Silverstein as the CAA representative on the Task Force replacing Caroline Grech.
