IN THE MATTER OF an application by **ABBRUZZESE HOLDINGS ATTEN: ANGELO ABBRUZZESE**, with respect to Part of Lot 26, Concession 8, (Lot 5, Registered Plan No. 65M-2928, municipally known as 23 Forest Heights Blvd., Kleinburg.)

The subject lands are zoned RR, Residential under By-Law 1-88 as amended and further subject to exception 9(741).

The applicant is requesting a variance to permit the construction of a two storey single family detached dwelling, with attached garage, as follows:

Proposal

1) Maximum lot coverage of 11.5%.




