It has come to my attention that certain contributions made to a candidate for Vaughan Council, namely Mr. Gino Rosati were flagged as exceeding contribution limits under section 86 of the *Municipal Elections Act, 1996*.

Said contributions were made separately from myself, Paul Federico and my spouse, Marianna Federico both residing at Orlon Cres in Richmond Hill. From my understanding, each individual who is a resident of Ontario is allowed to make a maximum contribution of \$1200. In our case, because my wife and I share one bank account, our contributions, notwithstanding being from the same account, should be viewed as 2 separate contributions as the cheque for my contribution was signed by myself whereas my wife's cheque was signed by her.

Given the circumstances I would therefore respectfully suggest that a contravention of the Act has not in fact occurred and would ask for your confirmation of same.

Please be advised that I am the lawyer for Peter Cipriano.

I am in receipt of your correspondence dated May 15, 2019 and received by my client on May 22, 2019.

My client acknowledges that he made the contributions as set out in your memorandum to the Compliance Audit Committee dated May 13, 2019. Mr. Cipriano was, at no material time, aware of the most recent amendments to the *Municipal Elections Act* (the "Act").

Mr. Cipriano, at all material times, was acting in good faith and had relied on his bookkeeping staff and administration staff at his office to monitor the amount of contributions being made and was under the mistaken belief that he was not in breach of any laws. It is noteworthy that two of the candidates were not elected to office. Mr. Cipriano took no steps to mislead/misguide the City Clerk/Returning Officer.

Mr. Cipriano's contributions have, in no material manner or otherwise, had any effect on the ultimate election of Vaughan's council.

To penalize Mr. Cipriano for not knowing the most recent amendments to the Act and to not hold him to a good faith standard, is contrary to the principles underlying the legislation. The Act's legislative intent is to preserve integrity and transparency in the electoral process insofar that it sets out rules guiding the actions of both the candidate and the contributor. In this case, Mr. Cipriano has acted in good faith and has been transparent with respect to his actions.

I shall be attending with Mr. Cipriano before the Compliance Audit Committee on June 6, 2019, in Committee Room 242/243 at the City of Vaughan at 7:00 pm to make submissions/statement(s) to the committee.
