According to past engineering and environmental reports there are environmental issues that reside on these properties. Where the Canadian Tire is being proposed that land is home to many monitoring wells that should have reports with results enclosed in all samples that were pulled from the wells on the Loblaw's property that should be spoken to on December 5/2017 before Council or city staff even consider any approvals on these proposed developments.

Also I like Mr. Carella to inform the public on how many Town halls he has held for the public to be engaged in these proposed developments being presented to the city of Vaughan.

I have a string of emails requesting public engagement of these proposed developments being proposed to the city of Vaughan and over the course of the year Mr. Carella has failed to communicate and public information about proposed commercial developments in the Northwest Corner of HWY 27 on Loblaw property.

In conclusion until all environmental issues are remediated and cleared there should be no zoning by-law amendments being approved for the File Z. 17. 025. Of the official plan File OP. 17.009
