#### **Communications Plan**

The road name changes were advertised for two consecutive weeks on the City Page of the City's website. The name change will not affect any homeowners as there are currently no area residents residing on this street. Emergency services have been notified of the proposed name change.

## Purpose

To enact a by-law to change the name of Street "A" from Gallant Drive to Dunrobin Crescent, and Street "F" from Hyde Drive to Finland Drive.

#### **Background – Analysis and Options**

At its meeting of November 19, 2013, by its adoption of Item 11 of Report No. 47 of the Committee of the Whole, Council directed staff to commence procedures as required by the *Municipal Act* to advertise and schedule a Public Hearing to change the name of Street "A" from Gallant Drive to Dunrobin Crescent, and Street "F" from Hyde Drive to Finland Drive. Background to the proposed name changes is set out in the Council Extract (Attachment 1).

The notice (Attachment 2) was advertised on the City Page of the City's Website during the weeks of November 25th and December 2<sup>nd</sup>, 2013. The appropriate agencies have been notified of the proposed changes. No objections have been received.

## **Communications Plan**

Through the City's street name change process, the street renaming will be advertised for two consecutive weeks on the City's website, prior to the enactment of a By-law. The advertisement will explain the purpose of the renaming and include a map identifying the streets to be renamed.

## Purpose

To direct the City Clerk to initiate the City's street name change process to change street names in Plan 65M-4383 (Gallant Drive to Dunrobin Crescent and Hyde Drive to Finland Drive).

## **Background – Analysis and Options**

The subject plan shown on Attachment #1 is located north of Major Mackenzie Drive, between Huntington Road and Regional Road 27, in Part of Lot 21, Concession 9, City of Vaughan.

Street names were approved by Vaughan Council on June 26, 2012 for the approved and now registered Plan of Subdivision. Prior to Vaughan Council's approval, discussions were ongoing between the applicants, City of Vaughan staff and the Region to determine acceptable names.

The street names Gallant and Hyde were not properly screened and duplicated with another approved development.

The Region of York Transportation and Community Planning Department has no objection to the proposed names, which are approved names in the City's Reserve List of street names as approved by Vaughan Council on June 26, 2012. The Vaughan Fire and Rescue Services Department and Vaughan Development Planning Department have also reviewed the proposed street names, which are considered to be satisfactory.

The proposed street names are consistent with the City's Street Naming Policy that was approved by Vaughan Council on June 26, 2012.

The Development Planning Department has no objection to the proposed street name changes and recommends that Vaughan Council direct the City Clerk to initiate the City's street name change process.





LOCATION: Part of Lot 21, Concession 9


