

#### NOTICE OF PUBLIC HEARING

# Pre-Consultation and Complete Application Submission Requirements for Planning Applications Section 10.1.3, Vaughan Official Plan - Volume 1

The City is updating its policies for pre-consultation and complete submission requirements for planning applications in response to several changes in Provincial and Regional policy since their origin in 2010. The *Planning Act* permits municipalities to require applicants to consult with the municipality before submitting their application for development approval. The policy framework for this consultation is contained in the Vaughan Official Plan - Volume 1, Section 10.1.3 (Pre-Consultation and Complete Application Submission Requirements).

Section 22 of the *Planning Act* prescribes that Council ensure that sufficient information and material is made available to enable the public to understand generally the proposal that is being considered by Council and that at least one public meeting is held for the purpose of giving the public an opportunity to make representations in respect of the proposed Official Plan Amendment.

## Your chance to provide feedback

A Public Hearing is being held to receive public input on the proposed amendment(s) to the Official Plan as it relates to the Pre-Consultation and Complete Application Submission Requirements for planning applications. The Public Hearing offers an opportunity for the public to provide comments on the proposed Official Plan Amendment prior to its further consideration by the City of Vaughan Committee of the Whole.

If you are submitting letters, facsimiles, e-mails, presentations or other communications to the City, you should be aware that your name and the fact that you communicated with the City will become part of the public record and will appear on the City's website. The City will also make your communication and any personal information in it such as your address and postal code or e-mail address available to the public unless you expressly request the City to remove it.
