At this time, there is ample funding available in the Fire Equipment Replacement Reserve to address the anticipated shortfall.

The purpose of this report is to update Council on the development of Capital Project FR-3599-13, and advise that a projected funding shortfall of approximately \$250,000 has been identified during the preliminary design phase.

#### **Background - Analysis and Options**

The original project scope for FR-3599-13 was to update crew quarters at Fire Stations 7-5 to more efficiently accommodate an additional emergency response crew. Fire Station 7-5 currently houses 20 staff and that is expected to double shortly. During the design phase of this project, which began in November 2014, it became clear that in addition to updating the crew quarters as stated in the original 2013 budget request, the following work will also be necessary to support this growth:

- 1. Addition to Apparatus Bay
- 2. Addition to Kitchen
- 3. Rework Site Servicing & Landscape
- 4. Upgrade Existing Mechanical & Electrical System
- 5. Miscellaneous Interior Renovations/Conversion
