- 2. That this request for noise exemption be granted with the following conditions:
 - That construction communication notices be sent to surrounding residents and business owners within a 60 metre radius, in keeping with City standards, advising them of the impending work;
 - b) That the construction communication notices to residents and business owners include contact information for York Region Rapid Transit Corporation;
 - c) That the Applicant take measures to minimize idling of construction vehicles, avoid unnecessary revving of engines / use of airbrakes and to maintain equipment in good working order (including muffling devices) to minimize noise impacts.
 - d) That no construction take place on Sundays or Statutory Holidays.

This noise exemption is directly related to the vivaNext / H2VMC Project, contributing to accessible and frequent local transit service, supporting compact urban form and offering alternative modes of transportation.

Purpose

This report is to request Council approval of a request from Kiewit-EllisDon, A Partnership ("KEW") for an additional long term noise exemption to By-law 96-2006. KEW applied for, and was granted, a similar noise exemption from June 24, 2014 to December 21, 2014, (Item 37, Report No. 30). As the delegated authority under the By-law is only for eleven days, this Application requires Council authorization for exemption from the By-law.

Background - Analysis and Options

The City of Vaughan Noise By-law 96-2006 delegates authority to grant noise exemptions for construction purposes up to eleven days to the Department Head of Enforcement Services.

Kiewit-Ellisdon, A Partnership ("KED") has written to the City of Vaughan By-law & Compliance Department requesting an additional exemption to the Noise By-law for the purposes of construction in connection with the vivaNext / H2-VMC Project.

The scope of the H2-VMC Project primarily consists of road widening to allow for the installation of dedicated bus lanes associated with Viva Rapid Transit Routes. The construction work will include:

- Drainage work;
- Grading & paving;
- Fencing / barriers;
- Culvert extensions;
- Retaining structures;
- Sidewalk & station platform construction;
- Hard & soft landscaping;
- Widening of CN McMillian Bridge.

Construction work activities that will occur outside of the restrictions of the Noise By-law (i.e.: after 7pm and before 7am) will include:

- Paving and sub-base construction;
- · Electrical work;
- Drainage / utility work.

Noise Mitigation

The Applicant will be required to minimize idling of construction vehicles, avoid unnecessary revving of engines / use of airbrakes and to maintain equipment in good working order (including muffling devices) to minimize noise impacts. The primary sources of noise during construction will include:

- Clearing and grubbing (use of chain saws, dozers, excavators, etc.);
- Removal and demolition (use of excavators, breakers, milling machines, etc.);
- Excavating and grading (use of dozers, excavators, trucks, etc.);
- Paving and sub-base construction (use of dozers, excavators, rollers and compactors).

construction begins on the CN Bridge

To accommodate the road widening on Highway 7 West, crews will be working over the next two years to widen the CN Bridge. In order to safely do this, the median has been removed and starting next week traffic will be shifted to the north side of the bridge. Traffic lanes will be reduced and will remain shifted for the duration of the work. Please see details below:

Work dates: The week of February 17, for approximately 24 months*

Work hours: Although work will take place from 7am to 7pm, the lane closure will stay in place overnight 24 hours a day, 7 days a week.

Note: crews will be performing vibration work. At times, weekend work may be required.




Due to the nature of this work, there will be noise and vibration around the work area.



retaining wall construction continues on Highway 7 West

As part of rapidway construction, we will be building several retaining walls along Highway 7 West. Retaining walls are built to provide stability between two areas of land that sit at different heights. The retaining wall is used to hold the slope in place and support the higher level of ground. Crews will be building the wall on the north side of Highway 7, east of Creditstone Road as well as accessing the work area along McCleary Court.

Work dates*: Starting the week of April 23, for approximately 6 weeks*

Work hours: Monday - Friday from 7am-7pm [Note: some weekend work may be required]



- install fence and traffic control barriers around work zone
- excavate the work area

description of work

- build the retaining wall
- backfill and restore the area

Once the wall is built, the area will be restored.

what impacts will there be?

- There will be lane reductions inside the McCleary Court Community Environmental Centre's waste drop-off area.
- Access to the Community Environmental Centre will be maintained during its regular, seasonal hours of operation.
- At times, there will be temporary westbound curb lane closures along Highway 7, just west of the CN MacMillan Bridge.
- Wherever possible, sidewalks will remain open. If a sidewalk is closed, directional signage will be on site to guide pedestrians.
- Where bus stops are affected, directional signs will guide pedestrians to the nearest open bus stop.
- Due to the nature of this work, at times there will be noise and vibration around the work area. Monitoring will be conducted to ensure all levels are kept within industry standards.



- During the line painting work, east and westbound traffic lanes will be intermittently closed overnight from May 26 – 28. Due to the nature of this work there will be noise and vibration around work areas.
- Once line painting is completed, traffic lanes will be shifted north and narrowed. Three lanes will remain westbound, however eastbound traffic will be reduced to two lanes from Creditstone Road to east of the CN Bridge.
- Dedicated left-turn lanes at signalized intersections will remain and, where possible, a centre emergency services/shared left-turn lane will be provided.
- Where bus stops and sidewalks are affected, directional signs will guide pedestrians to the nearest open bus stop or sidewalk.
- Businesses are open during construction and access to driveways will be maintained.



- Avoid banging of tailgates and loader buckets.

Select travel routes to avoid noise sensitive areas.

After hours construction activities include:

- Paving and sub-base construction.
- Electrical works.
- Drainage and utility works.
