Recommendation

The Commissioner of Community Services in consultation with the Director of Purchasing Services, Director of Budgeting & Financial Planning and the Director of Parks & Forestry Operations recommends:

- 1. That the firm of Diamond Head Sprinklers Inc. be retained to provide irrigation maintenance services and central control administration for parks in the amount of \$49,759.55 (inclusive of HST) per year, for (3) three years with (2) two optional (1) one year terms, at a total cost of \$149,278.65 (inclusive of HST) for the first (3) three years, and,
- 2. That a contingency allowance of 15% be approved within which the Director of Parks & Forestry Operations be authorized to approve amendments to the contract if any; and,
- 3. That the Mayor and City Clerk be authorized to sign the necessary documents.

Background - Analysis and Options

The Parks & Forestry Operations Department manages 233 sports fields, 41 of these sports fields are irrigated with in ground irrigation systems. Irrigation has many benefits to turf as it extends the life span of the field, assists in maintaining healthy turf and reduces the risk of injury to players. Sixty percent (60%) of the irrigated fields are linked to a central control system. The central control system enables the department to monitor multiple sites across the City from one computer. The system also has the ability to safeguard against potential problems resulting from excess flow, incorrect programming and also reduces water waste due to varying weather conditions.

The benefits gained from the central control system have allowed the department to save on additional staffing resources as programming and monitoring of the irrigation systems is centralized, thereby reducing staff visits to each field daily to make the necessary adjustments.

In order to effectively monitor the software and perform the necessary scheduled maintenance, the Parks & Forestry Operations Department issued an RFP requesting proponents propose maintenance schedules and central control administration. The contractor will provide full season services including; system start-up and winterizations, backflow testing and certification, controller and weather station maintenance, sprinkler maintenance, monthly site visits to audit on site conditions, report on operational efficiencies of all systems, and administer and operate the central control system.

The project is considered high in complexity and is a multi year contract with a well-defined scope; however, there is a high probability of a number of unforeseen factors relating to aging infrastructure and wireless communications that may have an effect on the desired outcome. Therefore, a contingency allowance of 15% has been identified as an appropriate amount to address any unforeseen work in completing the scope of this project.

The Request for Proposal was publicly advertised on OPBA, Bidingo and on the City Web Page. The RFP closed at 3:00 p.m. on September 5, 2012. Five (5) RFP documents were picked up and upon opening, the following five (5) Proponents submitted proposals:

- 4. Diamond Head Sprinklers Inc.
