**PARKING PROHIBITION REVIEW  
ISLINGTON AVENUE, NORTH OF JOHN STREET  
WARD 1**

**The Committee of the Whole recommends approval of the recommendation contained in the following report of the Deputy City Manager of Public Works and the Director of Transportation Services, Parks and Forestry Operations, dated February 7, 2017:**

**Recommendation**

The Deputy City Manager of Public Works and the Director of Transportation Services, Parks and Forestry Operations, in consultation with the Director of By-Law and Compliance, Licensing and Permit Services recommend:

1. That Council amend Schedule "A" Part I of Parking By-law 1-96, as amended, to remove the no parking prohibition on the east side of Islington Avenue, from 65 metres south of John Street to 135 metres south of Treelawn Boulevard;
2. That Council amend Schedule "A" Part I of Parking By-law 1-96, as amended, to add a parking prohibition on the east side of Islington Avenue, from 65 metres south of John Street to John Street; and
3. That Council amend Schedule "A" Part I of Parking By-law 1-96, as amended, to add a parking prohibition on the east side of Islington Avenue, from 64 metres north of John Street to 135 metres south of Treelawn Boulevard.

This report contributes to the goals and objectives within Green Directions Vaughan, The City's Community Sustainability and Environmental Master Plan, specifically:

Goal 3: To ensure that Vaughan is a city that is easy to get around with a low environmental impact.

**Economic Impact**

The cost associated with the removal of the parking prohibition on the east side of Islington Avenue for snow removal and re-establishment of the three (3) hour parking restriction is estimated to be \$14,000 annually.

##### **Purpose**

The purpose of this report is to assess the feasibility of removing a no parking prohibition on the east side of Islington Avenue and re-establish the three (3) hour parking restriction, to increase short term visitor parking to the Kleinburg village area.

##### **Background - Analysis and Options**

**Currently, a parking prohibition (i.e. no parking anytime) is in effect on the east side of Islington Avenue, within Kleinburg Village.**

Kleinburg Village is located on Islington Avenue roughly from Stegman's Mill Road to Nashville Road. Islington Avenue is a two (2) lane minor collector roadway with a 20.0 metre right-of-way and an 8.0 metre pavement width. There are sidewalks on both sides of Islington Avenue encouraging pedestrian activity. Islington Avenue also features a rolled curb at many sections to permit vehicles to park off-street without negatively impacting two-way traffic.

Currently, a parking prohibition (i.e. no parking anytime) is in effect on the east side of Islington Avenue from 65 metres south of John Street to 135 metres south of Treelawn Boulevard. This area is approximately 245 metres. The proposal would revise the existing parking prohibition to permit parking for a maximum of 3 hours for 64 metres. The area is shown in Attachment No.1.

**Residents and the business community of Kleinburg Village have raised concerns regarding the current parking prohibition on the east side of Islington Avenue.**

Local residents and the Business Improvement Area (BIA) have concerns for available parking for visitors to the Kleinburg Village core. The existing parking prohibition in question is on the east side of Islington Avenue from 65 metres south of John Street to 135 metres south of Treelawn Boulevard.

**A traffic operational review confirmed that revising the parking prohibitions will not negatively impact traffic flow on Islington Avenue.**

Staff investigated existing conditions on Islington Avenue and found that if parking prohibitions were to be revised, two-way traffic flow will not be impacted as the proposal would have vehicles parked off the travelled portion of the road.

Existing streetscape features (benches, flowerbeds, etc.) are present from John Street to 65 metres south of John Street. All of these existing features prevent off-street parking in this area. For the purposes of this prohibition proposal, it is recommended to make no changes to this section.

However, from John Street to 135 metres south of Treelawn Boulevard, there are existing continuous mountable curbs and interlock pads that range in width from 1.1 metres to 2.35 metres. Parking width specifications require a minimum width of 2.2 metres.

Staff have investigated and found the 2.35 metre mountable curb extends from John Street to 64 metres north of John Street, which would be suitable for parking, based on sight visibility and operations.

**The residents considered directly impacted by the proposal and the BIA have been informed of this proposal.**

The City has received no objections to date with the parking prohibition removal proposed. There are three residences on the east side of Islington Avenue that could be considered directly impacted by the proposal.

To date, no objections or comments have been received from the directly impacted residents.

**The proposed parking prohibition revision would increase the number of available parking spaces for the Kleinburg Village Core, without adversely impacting two-way traffic flow.**

Through consultation with the BIA, it has become clear that additional parking for visitors to the Kleinburg Village Core is desired. The proposal to revise the existing parking prohibitions on the east side of Islington Avenue will not adversely impact two-way traffic flow as the parking will be accommodated off-street.

The facilities of an interlock surface and mountable curb are already in place, requiring only the revision of existing parking prohibitions. There is an available width of 2.35 metres from John Street to 64 metres north of John Street that would be appropriate for off-street parking. The additional parking area will be a benefit to the community and local businesses.

Re: Approval of Parking Along the East Side of Islington Avenue, Kleinburg, Ontario

Hello all,

I am writing in respect to the Special Committee of the Whole Meeting that is scheduled for today, Tuesday, February 21, 2017, with regards to the request for approval of additional parking along the east side of Islington Avenue in Kleinburg, north of John Street.

We are all aware of a significant shortage of parking spaces in the Kleinburg Village Core, however, I do not feel that this approval of parallel parking along Islington, north of the village core, will do much to alleviate our parking problem. In fact, I believe it will only lead to illegal parking, encroaching onto residential streets in the area, namely; Treelawn Blvd., Bell Court and Lester Pearson. Enforcement of this illegal parking will only lead to other problems and concerns in our area.

K.A.R.A. has been a huge advocate of new developments being guided to and abiding by our Official Plan, with particular emphasis on ensuring that parking by-laws are met by all new applications. Approval of additional parking spaces close to a residential community contradicts the fact that new development should ensure adequate parking for both residents and visitors.

I believe it is time for the City of Vaughan to explore other alternatives for parking in Kleinburg as this is not an adequate solution. Parking should remain in the village core close to shopping and services and there are other options we should take a look at. Every effort should be made to ensure a viable village core and I do understand that we need to create additional parking, but north of John Street, the sidewalks become very slippery in the winter season and in inclement weather. I don't think that this proposed parking will address the real problem. We should also take a look at the cash-in-lieu parking fund that was established some time ago.

In closing, we do not support the approval of parallel parking along Islington and would like to see the City of Vaughan, together with the BIA and KARA, come up with other solutions.

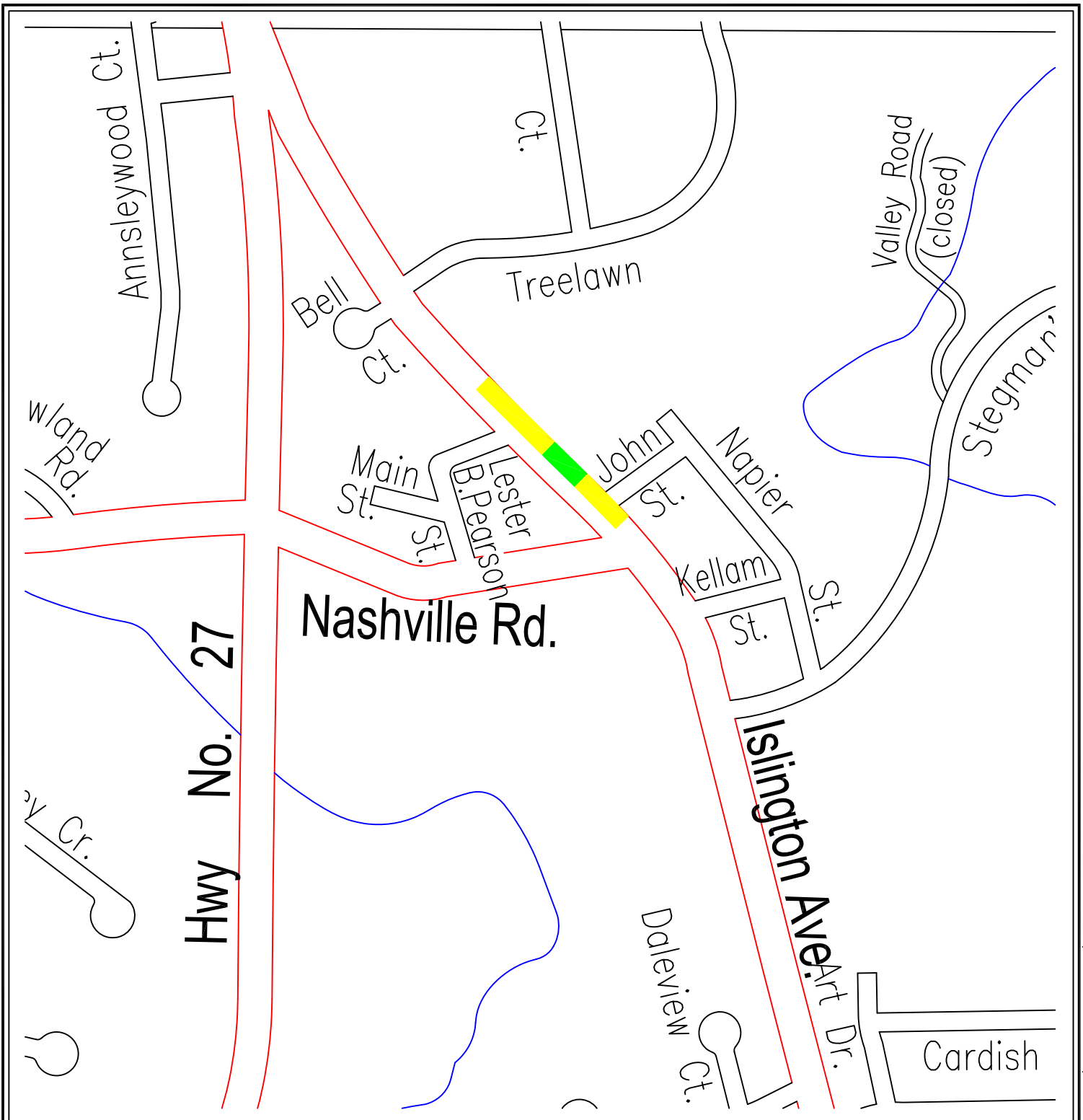
