A contingency in the amount of \$210,000 is requested as the number and different types of roofs to be replaced or repaired increase the complexity and risk with the work to be completed. Once work is underway on the roof upgrades, unforeseen circumstances and additional issues may be uncovered that would require the contingency allowance.

Background - Analysis and Options

The Roof upgrade for installation of solar panels at six (6) community centres, Chancellor CC, Father Ermanno Bulfon CC, Maple CC, Dufferin Clark CC, Garnet A. Williams CC, and North Thornhill CC project consists of the repair and upgrade of the roofs. The City is working in partnership with PowerStream for the installation of solar arrays on the rooftops of the community centres. The work to repair and or replace roofs at these locations is required to meet the requirements of the solar installations. The project will strengthen the City's commitment to environmental stewardship. Once installed, arrays are projected to generate an estimated 850 kW of energy per year to the PowerStream grid and approximately \$47,750 in annual lease payments to the City.



Tender T16-464 was advertised on the City of Vaughan's website, Biddingo and OPBA and closed on January 26, 2017. A total of ten (10) bids were submitted for this tender, two (2) of which were deemed non-compliant. The compliant bid results are as follows:

Based on the review of the submitted bids, staff recommends awarding the contract for Tender Bid T16-464, roof upgrade for installation of solar panels at six (6) community centres, Chancellor CC, Father Ermanno Bulfon CC, Maple CC, Dufferin Clark CC, Garnet A. Williams CC, and North Thornhill CC, to the lowest compliant bidder, Nortex Roofing Ltd.
