**ASSUMPTION – EURO ESTATES SUBDIVISION
PLAN OF SUBDIVISION 65M-4158 (19T-03V24)
WARD 3 VICINITY OF MAJOR MACKENZIE DRIVE AND WESTON ROAD**

The Committee of the Whole recommends approval of the recommendation contained in the following report of the Commissioner of Engineering and Public Works and the Director of Development/Transportation Engineering, dated February 25, 2014:

Recommendation

The Commissioner of Engineering and Public Works and the Director of Development/Transportation Engineering recommend:

1. That Council enact the necessary by-law assuming the municipal services that are set out in the Subdivision Agreement for Plan 65M-4158, and that the Municipal Services Letter of Credit be released.

Contribution to Sustainability

The municipal services recommended for assumption in this report have been designed and constructed in accordance with City standards which include consideration for sustainability.

Economic Impact

Upon assumption of this subdivision, approximately 0.64 lane kilometers of roadway and associated municipal services including sanitary sewers, watermain, street lighting, streetscaping, sidewalk, etc., will be added to the City's network of infrastructure. This additional infrastructure is valued at \$547,851 and will incur the normal expense associated with annual operation and maintenance activities of approximately \$15,175 shown on the following chart:

Purpose

The purpose of this report is to inform Council that the municipal services constructed pursuant to the Subdivision Agreement between Euro Estates Inc. and the City are complete and can be considered for assumption by the City.

Background - Analysis and Options

The Euro Estates Subdivision, Plan of Subdivision 65M-4158 is a 43 lot residential subdivision including 1 commercial block. It is located south of Major Mackenzie Drive and west of Weston Road in Ward 3 as shown on Attachment No.1.

The Subdivision Agreement with Euro Estates Inc. was executed on June 5, 2009, and the Plan of Subdivision was subsequently registered on January 15, 2010. The roads and municipal services in Plan 65M-4158 were substantially completed on March 22, 2012.

The Developer has maintained the municipal services in the subdivision during the required minimum thirteen month maintenance period and has rectified all deficiencies. In addition, the grading of all lots in the subdivision has been certified by the Developer's Engineering Consultant.

All documentation required by the Subdivision Agreement for assumption has been submitted. Engineering staff, in conjunction with the Developer's Consulting Engineer, have conducted all the necessary inspections of the municipal services in the subdivision and are now satisfied with the extent of the works.

The Commissioner of Engineering and Public Works has received clearance from all pertinent City Departments including Development/Transportation Engineering, Building Standards, Parks Development, Parks and Forestry Operations, Public Works, and Clerks. The Development Finance & Investments Department has confirmed that all of the City's financial requirements associated with this subdivision have been satisfied.

Accordingly, the Developer has requested that the roads and municipal services in the subdivision be assumed by the City, and that the development securities held by the City be released.

Relationship to Vaughan Vision 2020

The development of this subdivision and the assumption of the municipal services are consistent with Vaughan Vision 2020, which encourages management excellence through planned and managed growth and the maintenance of City assets and infrastructure. This report is consistent with the priorities previously set by Council and the necessary resources have been allocated and approved.

Regional Implications

There are no Regional implications with respect to the assumption of the municipal works within this subdivision development.

Conclusion

The construction of the roads and municipal services associated with the Euro Estates Subdivision Plan of Subdivision 65M-4158 has been completed in accordance with the Subdivision Agreement. 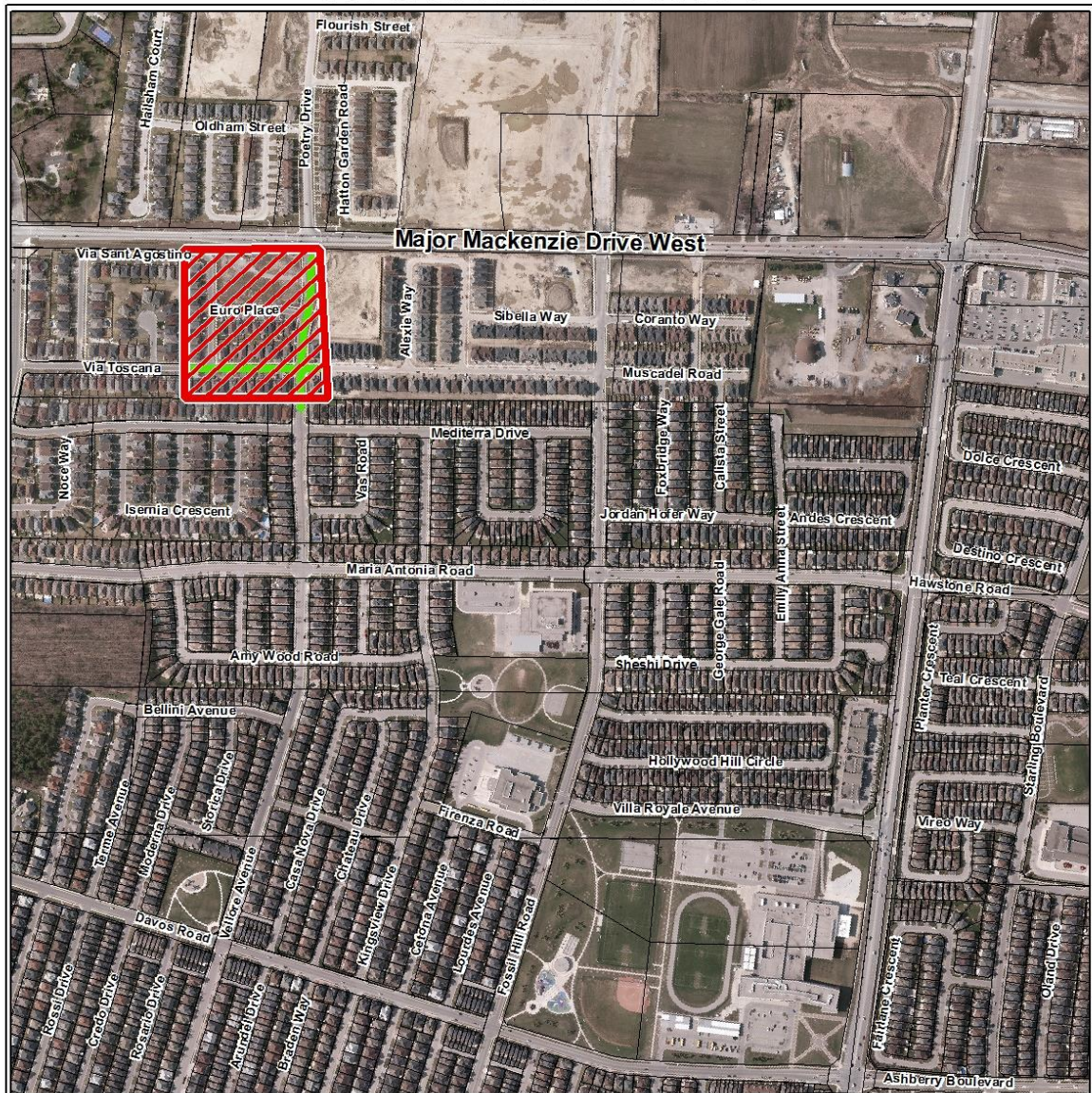

BY-LAW NUMBER 035-2014

A By-law to assume Municipal Services in Euro Estates Subdivision, 19T-03V24, Registered Plan 65M-4158.

WHEREAS the Subdivision Agreement between the City of Vaughan and Euro Estates Inc. provides for the installation of certain public services.

AND WHEREAS the Commissioner of Engineering and Public Works has received certification that the services in Registered Plan 65M-4158, have been constructed and installed in accordance with City specifications.

NOW THEREFORE the Council of The Corporation of the City of Vaughan ENACTS AS FOLLOWS:

- I. THAT the services in Registered Plan 65M-4158, more particularly described in the Subdivision Agreement between The Corporation of the City of Vaughan and Euro Estates Inc. dated June 5, 2009, be and they are hereby assumed as public services.
