#### **2015 EARTH DAY TREE PLANTING**

The Committee of the Whole recommends approval of the recommendation contained in the following report of the Interim City Manager and the Manager of Environmental Sustainability, dated March 3, 2015:

##### **Recommendation**

The Interim City Manager and the Manager of Environmental Sustainability in consultation with the Director of Transportation Services and Parks & Forestry Operations recommend:

1. That the City of Vaughan partner with local area Scotiabank branches in a tree planting event on April 22, 2015 to celebrate Earth Day;
2. That staff in Corporate Communications be directed to support this event;
3. That staff report back on the Earth Day Tree Planting through the *Green Directions Vaughan* annual update.

##### **Contribution to Sustainability**

Vaughan's participation in and promotion of the Earth Day tree planting event supports *Green Directions Vaughan*, Goal 5: To be leaders in advocacy and education on sustainability issues. The Earth Day event aligns well with the City's ongoing environmental outreach program with Vaughan businesses and the community.

There are no additional economic impacts resulting from this report. Scotiabank has committed to securing the trees, which align with standards set by Parks & Forestry Operations, for this initiative. The City of Vaughan will provide in-kind support through provision of staff time to participate on the steering committee to coordinate the event, equipment to prepare the area for planting, mulch for the area being planted and a location to host a sponsor appreciation event.

For the past eight years, the City of Vaughan has coordinated the 20-Minute Makeover, a community wide clean-up event, to coincide with Earth Day.

Tree planting is a critical component to maintaining an urban tree canopy. The urban tree canopy helps to mitigate climate change and air pollution impacts as well as provides energy conservation benefits. In addition, the City of Vaughan has effectively used its urban forest comprised of boulevard trees, green Spaces, parks, natural areas, and woodlots to visually enhance outdoor spaces, creating inviting spaces for visitors, businesses, and a source of civic pride. Strategic planting continues to be a key component of the five year plan to expand and diversify the Urban Forest.
