In 2013, the City completed an update to the Active Together Master Plan (ATMP), the City's strategic plan for Parks, Recreation and Libraries. The 2013 ATMP identifies the need to undertake a comprehensive study to guide the renewal and redevelopment of parks and open space facilities which can act as a catalyst for improving quality of life and revitalizing existing areas throughout the City.

Key observations and recommendations of the 2013 ATMP include:

- Lack of dedicated funding for park renewal is an impediment to improving quality of parks and open space facilities in Vaughan;
- Lifecycle repairs and replacements should be coordinated to refurbish entire parks at one time rather than taking a piecemeal approach;
- Use of cash-in-lieu of parkland (CIL) funding should be considered to offset the cost of renewing and revitalizing existing parks intended to serve areas of residential intensification; and
- Appropriate community and public-private partnerships should be promoted for use in the municipal parks system in order to leverage additional resources, expedite development and improve accessibility.

Vaughan's parks and open space system is relatively modern, with many of the City's parks having been built in the late 1990s and early 2000s to address the needs of a rapidly growing city. The City is currently experiencing a substantial shift from greenfield residential development to infill development and intensification projects within existing communities which is placing pressure on existing facilities. Pressures for park renewal and redevelopment is also being driven by other factors such as declining facility condition, safety concerns, legislative requirements as well as changes in leisure preferences and socio-demographic composition. To ensure that the City's parks and open space system remains relevant and that existing parks are properly aligned with changing community needs, a strategy is required to sustainably plan for parkland renewal and redevelopment.

In recent years there has been a growing concern that existing parks and outdoor recreation facilities within the City's established communities are not sustainable due to pressures from intensified development, age of park facilities and backlog of required capital and maintenance improvements. In addition, many of the park and open space facilities within older established communities may not be capable of meeting the future needs of park users. The trend of park and open space facility renewal is being experienced by many municipalities across the Greater Toronto Area and throughout North America as municipalities attempt to balance user needs while achieving fiscal sustainability.

As such, the City requires a comprehensive strategy for managing the renewal and redevelopment of parks and open space facilities over a 10-year period (2018-2028). Through an analysis of existing facilities and a review of emerging trends and pressures from population growth, the Parks Redevelopment Strategy will identify potential service delivery gaps and review and recommend an approach to prioritize park redevelopment initiatives that properly align with the City's Service Excellence plan and that respond to changing community needs. It is intended that this strategy will guide and inform capital investment decisions regarding major renovations and the repurposing/decommissioning of older and under-utilized park and open space facilities.

RFP16-392 Consultant Services for Parks Redevelopment Strategy was advertised on the Bids and Tenders Section of the City's Website, Biddingo and Ontario Public Buyers Association (OPBA) on December 22, 2016 and closed on January 30, 2017. 1 addendum was issued to respond to questions received. A total of 10 Plan Takers registered for this RFP, and 2 compliant bids were received as per below:
